In accordance with Association policy, regular communication will be provided to NLTA members by way of periodic updates on the status of the collective bargaining process.

Opening proposals for a new Provincial Collective Agreement were exchanged in March 2017. Since then, negotiations sessions have proceeded on October 17-19 and November 6-7, 2017, January 29-February 2, and February 28-March 1, 2018. A number of detailed sets of proposals and counter proposals have been exchanged and discussed between the NLTA and employer negotiating teams. Discussions continue in the context of government still seeking significant financial concessions. Your negotiating team is standing firm and working hard on behalf of teachers. Talks are still at an early stage in the overall bargaining process. Dates for the two sides to meet again have been proposed but are not yet confirmed.

Government appointed a new chief negotiator in January – Bernadette Cole-Gendron, who was chief negotiator for the employer in the last round of bargaining, has replaced George Joyce in that role. As well, due to a District staff change, newly appointed NLESD Assistant Director for Human Resources, Ed Walsh, has replaced Lloyd Collins on the employer negotiating team as of January.
