# II. OPENING SESSION

A. The 2017 Biennial General Meeting was officially opened at 7:05 p.m. on Tuesday, April 18, 2017. The opening session commenced with the singing of "O Canada" and the "Ode to Newfoundland" led by the duo Johnson and Lear, substitute teachers with the NL English School District. The Chairperson reviewed with delegates the procedures in place for BGM resolutions received from branches and special interest councils and for resolutions from the floor.

#### E. Minutes of the 2015 Biennial General Meeting

# 1. Adoption

**Loch-Sheppard:** That the Minutes of the 2015 Biennial General Meeting be

accepted as presented.

# 2. Business Arising

# a) Report on Resolutions from the 2015 BGM

Discussion took place on the Report on Resolutions from the 2015 BGM, which contained information on the actioning of resolutions that had been accepted or referred to Executive at that BGM. (A copy of the Report is attached to the Official Minutes.)

#### F. Proposed By-Law Changes

The Chairperson noted that a two-thirds majority is required in order for by-law changes to be approved. Throughout these proposed changes, additions to current policy appear in **bold print** and deletions appear in <del>strike through</del>.

#### 1. From Provincial Executive

a) By-Law XI. – Nominations and Election for Executive [Nomination for Executive by Signatures of Members]

**Dinn-Ingram:** That Sections A.(1), C. and G. of By-Law XI. – Nominations and Election for Executive be amended to read:

"A. Any member of the NLTA in good standing\* is eligible for nomination and election to the Executive, providing:

- (1) Nomination papers are signed by at least 10 members in good standing\*, each signature being witnessed by
  - (a) an officer of a branch; or
  - (b) a member of the NLTA Executive; or
  - (c) a Commissioner for Oaths.

and submitted to the Electoral Committee, appointed by the NLTA Executive.

- (1) Nominations for the Executive shall be provided by the branches and by groups of 10 or more teachers where no branch exists. Any number of nominees may be submitted by each regional and unattached local branch providing that the consent of each nominee is obtained by the branch, and the nomination is approved by a motion at a duly constituted general branch meeting.
- C. Nominees are free to contact branches and special interest councils in any way they see fit keeping in mind the professional Code of Ethics. and Bbranches and special interest councils may or may not instruct delegates to the Convention as they see fit, with the understanding that after the first ballot is cast at the Convention, delegates are released from their instructions and may vote at their discretion.
- G. No member shall be eligible to be a member of the Executive unless such person is residing in, or actively teaching in, the province of Newfoundland **Labrador** during the term of office."

And that this by-law change take effect following BGM 2017.

**CARRIED** 

b) New By-Law XIII. – Nominating and Election Procedures for Vice-President [Election of the Vice-President at BGM]

**Dinn-Drover:** That a new By-Law XIII. – Nominating and Election Procedures for Vice-President of the NLTA By-Laws be added to read:

- "A. Any member of the NLTA in good standing is eligible for nomination and election to the office of Vice-President, providing:
  - (1) Nomination papers are signed by at least 10 members in good standing\*, each signature being witnessed by
    - (a) an officer of a branch, or
    - (b) a member of the NLTA Executive, or

(c) a Commissioner for Oaths

and submitted to the Electoral Committee, appointed by the NLTA Executive.

- (2) The Electoral Committee shall receive nominations for the office of Vice-President up to the commencement of the opening day of Convention sessions in accordance with By-Law XIII.A.(1). Such nominations must be accompanied by a short biographical sketch, an election statement, and a signed statement by the candidate of willingness to serve under conditions from time to time established by the Convention and applicable during the term sought.
- (3) Subject to XIII.A.(1), for publication in the Convention *Bulletin* nominations must be postmarked or hand delivered to the NLTA Head Office not later than the date which is two months prior to the opening date of Convention.
- B. Photographs and information on candidates referred to in XIII.A.(3) must be published in The Bulletin at least one month prior to the opening date of Convention.
- C. Nominees are free to contact branches and special interests councils in any way they see fit, keeping in mind the professional Code of Ethics. Branches and special interest councils may or may not instruct delegates to the Convention as they see fit, with the understanding that after the first ballot is cast at the Convention, delegates are released from their instructions and may vote at their discretion.

#### D. Balloting

The Vice-President shall be elected by ballot on the first day of Convention, as per the following:

- (1) Voting shall be by written secret ballots issued to voting delegates to Convention as defined by Section 10 of the NLTA Act;
- (2) Ballots shall be collected and counted by the official scrutineers appointed by the Convention, in the presence of the Electoral Committee, and one representative for each candidate, if s/he so desires;
- (3) The results of each ballot shall be announced by the Chairperson of the Electoral Committee:

- (4) In the event that the names of more than two candidates appear on a ballot, the candidate receiving the most votes must have a majority of the registered delegates to be declared elected;
- (5) If no majority of votes is registered on the initial or succeeding ballots, where more than two candidates are involved, the candidate receiving the least number of votes shall be dropped and balloting will continue;
- (6) On a ballot containing the names of two candidates, the candidate receiving most votes shall be declared elected;
- (7) In the event of a tie on a ballot with only two candidates, a further ballot shall be held after each candidate has been given the opportunity to address the Convention. If another tie then results, each member of the Electoral Committee shall cast a secret ballot to break the tie before the results of the ballot are released. Such a ballot shall be conducted by the Chairperson of the Scrutineers Committee.
- E. Anyone alleging irregularities in nomination or election procedures must make such allegations known in writing to the Chairperson of the Electoral Committee at the Convention not later than 30 minutes after the announcement of the results of the election. Upon receiving such allegation, the Chairperson of the Electoral Committee must appoint a committee of three registered delegates, excluding nominees, who will investigate the allegation and report their findings and recommendations to the Chairperson of the Electoral Committee before 10:00 a.m. of the session of the following day of the Convention. In the event that the allegation of irregularities is accepted as proved, by a majority of the committee appointed to investigate the matter, the matter and conclusions must be reported to the Convention by the Chairperson of the Electoral Committee. After receiving the report of the Electoral Committee the Convention shall, by a 3/3 vote of registered delegates, allow the election to stand or otherwise a new election shall be held in respect of the Executive positions affected by the irregularity."

**DEFEATED** 

The Chairperson informed delegates that since the proposed new By-Law XIII. had been defeated, the proposed changes to current By-Law XII. – Nominating and Election Procedures for Officers and current By-Law XV. – Elections would not be presented.

The business session recessed at 10:30 a.m. and reconvened at 10:45 a.m.

G. Proposed By-Law Changes (contd.)

#### 1. From Branches

a) By-Law X. – Convention [Number of Delegates Per Branch to Attend BGM] (Appalachia Branch)

**Blundon-Sheaves:** That By-Law X – Convention be amended in part to

read: "Delegates shall be elected from the legally constituted local and regional branches in the ratio of one to every 85 100 members, or fraction thereof, in

the branch."

It was agreed to replace the number "85" with the number "75".

**Santos-Vivian:** That the motion be tabled.

**CARRIED** 

b) By-Law XV. – Elections [Timing of Election for NLTA President and Vice-President] (Appalachia Branch)

**Blundon-Dwayne Parsons:** That By-Law XV.A. – Elections be amended to read as follows:

"Elections for President and Vice-President shall be held on a day selected by the Electoral Committee, as appointed under section B. of the By-Law, within three weeks of the Convention referred to in By-Law X on the first Tuesday in December in the year prior to the year of the expiry of the term of office for that position. Election information shall be published in *The Bulletin* at least one month prior to the date of the elections." and

That By-Law XIII.A.(1) – Duties of Officers (Office of the President) be amended to read as follows:

"The term of office shall be for a two-year period from August 1 in the year following the year the President was elected to July 31 of the second year following."

**DEFEATED** 

c) By-Law XII. – Nominating and Election Procedures for Officers and By-Law XV. – Elections [Electronic Voting for President and Vice-President] (Appalachia Branch)

Blundon-Sheaves:

That By-Law XII.D.(1) and (2) – Nominating and Election Procedures for Officers (Balloting) be amended as follows:

"The President and Vice-President shall be elected by ballot on election day as per the following:

- (1) Voting shall be by written secret ballots issued to active members as defined by By-Law III.
- (2) Ballots shall be collected and counted by the Branch Executive, in the presence of one representative for each candidates, if s/he so desires.", and

That By-Law XV. – Elections be amended by adding a new Section C to read:

"Notwithstanding any other provisions in these by-laws with respect to ballots and voting procedures for President and Vice-President elections, the Provincial Executive Council may determine that voting may be done by electronic means, in whole or in part, in accordance with procedures in NLTA policy approved by the Provincial Executive Council."

**CARRIED** 

d) By-Law XIII.A. – Duties of Officers (Office of the President) [Term of Office of the President] (Humber Branch)

Adey-S. Fifield: That By-Law XIII.A(3) – Duties of Officers (Office of the President) be amended to read: "The office shall not be held for more than successive terms by the same person. A portion of a term shall be considered as a full term."

Following the vote on the motion, division was called. Votes were then counted by a show of hands and the ruling of the chair that the *Adey-S*. *Fifield* motion had been defeated was upheld.

**MOTION - DEFEATED** 

President Jim Dinn left the room for discussion of the following proposed by-law change due a possible conflict of interest.

e) By-Law IV.B. – Associate Membership (Privileges) and By-Law V.B. – Life Membership (Privileges) [Privileges of Associate and Life Members] (St. John's Centre Branch)

**Jenkins-A. Dawe:** That By-Law IV.B. (1) and (2) – Associate Membership (Privileges) be amended to read:

- "(1) General Associate Members in this category may attend and speak at meetings of the Association, but not at meetings or portions of meetings relative to collective bargaining. They shall not be entitled to hold office in the Association, nor vote, nor be members of the Executive, except in the case of a retiring President who shall be eligible to serve fully on the Executive in the position of Past-President as an Associate Member for the year immediately following his or her term of office as President.
- (2) Retired Teachers Retired teachers in this category may attend and speak at meetings of the Association, but not at meetings or portions of meetings relative to collective bargaining. They shall not be entitled to hold office in the Association, nor vote, nor be members of the Executive, except in the case of a retiring President who shall be eligible to serve fully on the Executive in the position of Past-President as an Associate Member for the year immediately following his or her term of office as President. Other privileges may be granted as per Association Policy." and

That By-Law V.B. – Life Membership (Privileges) be amended to read:

"Life Members may attend and speak at meetings of the Association, but not at meetings or portions of meetings relative to collective bargaining. They shall not be entitled to hold office in the Association, nor vote, nor be members of the Executive, except in the case of a retiring President who shall be eligible to serve fully on the Executive in the position of Past-President as a Life Member for the year immediately following his or her term of office as President. Other privileges may be granted as per Association policy."

#### H. Resolutions to the 2017 BGM

Mr. Ash, Chairperson, noted that the Executive recommendations on resolutions to the 2017 BGM had been forwarded to delegates in their Convention kits. He reminded delegates of the current policy of the Association regarding resolutions to BGM in that all resolutions for which the Executive recommendation is to Carry or Amend and Carry are presented in a block motion. Delegates who wish to discuss any particular resolution within the block must ask to have it removed prior to the motion being passed by the assembly.

**Dinn-Ingram:** That the following resolutions be accepted as per the Executive

recommendations to Convention: Resolutions 4-5, 7-20.

It was agreed to remove Resolutions 4, 5, 7, 8, and 13 from the block of motions.

MOTION AS EDITED – <u>CARRIED</u>

The Chairperson noted that Resolution 21 from the St. John's Centre Branch is **CURRENT POLICY** of the Association and no vote is required.

Resolution 21 reads: "That the NLTA review, and make changes, if deemed necessary, to the composition of the Negotiating Team to ensure the make-up of the team reflects the make-up of the teaching population."

The following resolutions were <u>CARRIED</u> or <u>CARRIED AS AMENDED</u> as per the Executive recommendations:

#### *Resolutions in Category B – Programs and Services*

#### Resolution 9 -

That the NLTA lobby school boards to ensure, to the extent possible, that student Individual Education Plan meetings occur during school hours. (Conception Bay South)

**CARRIED AS AMENDED** 

#### Resolution 10 -

That the NLTA lobby school boards to split Kindergarten classes whenever class size exceeds the cap of 20 students. (Conception Bay South)

**CARRIED AS AMENDED** 

#### Resolution 11 -

That the NLTA lobby the Department of Education and school boards to ensure each teacher who is responsible for students has adequate physical space in which to teach those students. (Conception Bay South)

**CARRIED** 

#### Resolution 12 -

That the NLTA lobby the Department of Education and school boards to move to a true needs based teacher allocation model as opposed to a budget based model. (Green Bay)

**CARRIED AS AMENDED** 

#### Resolution 14 –

That the NLTA enter into discussions with the Department of Education and school boards to come up with a fair, responsible and ethically sound allocation formula for speech-language pathologists taking into consideration workload and geographical responsibility. (Speech-Language Pathologists Council and Labrador West)

CARRIED AS AMENDED

#### Resolution 15 -

That the NLTA Collective Bargaining Committee consider for inclusion in the opening proposals for the next round of negotiations a proposal for one non-teaching day during each reporting period for the purpose of report preparation. (Labrador West)

**CARRIED AS AMENDED** 

#### Resolution 16-

That the NLTA Collective Bargaining Committee consider for inclusion in the opening proposals for the next round of negotiations a proposal to place a cap on multi-grade classrooms of a maximum of two grades per class. (Labrador West)

CARRIED AS AMENDED

#### Resolution 17 –

That the NLTA enter into discussions with the Department of Education and school boards to address the issue of recruitment and retention of school based speech-language pathologists in this province. (Speech-Language Pathologists Council)

**CARRIED AS AMENDED** 

#### Resolution 18 –

# A. Report of the Electoral Committee – Election of Executive

Ms. Matthews noted that the election of Executive is governed by By-Law XI., subsections A.(2) and D. which state, respectively:

"The President shall, provided s/he so desires, be an ex officio Executive member for the year following the completion of the President's term of office."

"Seventeen Executive members shall be elected biennially, and the 10 who have the greatest number of votes shall, with the President, the Vice-President and a person holding office under XI.A.(2), where applicable, form the Executive Council. The remaining Executive members shall be classified as alternate members."

She informed delegates that no additional candidates had declared themselves as of the deadline for nominations. She then introduced each of the 13 declared candidates to the assembly.

Ms. Matthews noted that delegates must vote for not more than 10 candidates of their choice and that there are 105 eligible voters.

Ballots sheets were distributed and the vote was conducted.

# **Hutchings-Dale Parsons:**

That the motion be further amended by deleting the proposed new section m)iii) from the Financial Guidelines section of the Policy on the Election of the President and Vice-President by Province-wide Vote, which reads:

"Candidates receiving no less than ten percent (10%) of the overall votes cast on the initial ballot are entitled to reimbursement, subject to an audit of the disclosure of all financial contributions and expenditures, of the lesser of \$2,000 or forty percent (40%) of eligible expenses. Eligible expenses for reimbursement include the cost of travel, unpaid leave, printing and communications, but does not include the value of "in kind" contributions. The maximum funds to be made available to all candidates under this policy is set at \$10,000. In situations where the amount of eligible reimbursement for all candidates exceeds \$10,000, the reimbursement will be prorated as a share of \$10,000. For example, in a situation where six candidates are all entitled to the maximum \$2,000 reimbursement, each candidate will receive \$1666.66."

Discussion continued on the once amended *Dinn-Drover* motion to accept proposed policy changes.

Adey-Hutchings: That the motion be further amended by deleting the following words from the proposed new section m)iii) of the Financial Guidelines section of the Policy on the Election of the President and Vice-President by Province-wide Vote: "receiving no less than ten (10%) of the overall votes cast on an initial ballot".

The Special Recognition Award, instituted by Johnson Inc. to recognize the 100th anniversary of the Newfoundland and Labrador Teachers' Association, was presented by Mr. John Thompson, Senior Vice-President, Business Development and Marketing of Johnson Inc., to Robert Parsons, nominated by the Granforline Branch, for 2016, and to Deborah Green, nominated by the Humber Branch, for 2017. The award is presented annually to an active member of the NLTA who, while a teacher in the province, made a major contribution to the cultural, social and/or community life of Newfoundland and Labrador.

The Patricia Cowan Award for Support and Promotion of Education is named in honour of the first woman president of the NLTA. Established in 2007 to recognize individuals or groups outside the K-12 school system for their outstanding contribution to teachers and to the teaching profession either through their role as advocates or through a relationship with the

NLTA resulting in a positive impact on teaching and learning, the award is presented at Convention during the final year of a President's term. The President presented the award for 2017 to Geralyn Costello for her contributions to the Association during her almost 42 years of service as an employee of the NLTA.

Mr. Hicks, Chairperson of the Finance and Property Committee, informed delegates that an amendment had been made by Provincial Executive to the proposed budgets for 2017-18 and 2018-19 that had been printed in the Convention kit. This amendment added amounts in the Emergency Fund for the continuation of the Association's public awareness campaign for the next two budget years – \$700,000 for 2017-18 and \$1,050,000 for 2018-19. The revised document had been distributed to delegates at the BGM registration.

**Hicks-Langdon:** That the proposed NLTA Budgets for 2017-18 and 2018-19 be accepted. (*The Budgets are attached to these Minutes as Appendix A.*)

**CARRIED** 

**Blundon-Budgell:** That Convention rise from closed session.

#### **OPEN SESSION**

The Chair recognized the following guest to Convention: Clayton Rice, Treasurer of the Retired Teachers' Association of NL.

B. Proposed Changes to NLTA Policy (contd.)

Discussion continued on the twice amended *Dinn-Drover* motion to accept the proposed policy changes.

**MOTION AS AMENDED - CARRIED** 

**Dwyer-Jenkins:** That the proposed changes to By-Law IV.B. – Associate Membership

(Privileges) and By-Law V.B. – Life Membership (Privileges) be

reconsidered.

Following the vote on the motion, division was called. Votes were then counted by a show of hands and the ruling of the chair that the *Dwyer-Jenkins* motion had been defeated was overturned.

- C. Proposed By-Law Changes from Branches (contd.)
  - By-Law IV.B. Associate Membership (Privileges) and By-Law V.B. Life Membership (Privileges) [Privileges of Associate and Life Members] (St. John's Centre Branch)

**Jenkins-A. Dawe:** That By-Law IV.B. (1) and (2) – Associate Membership (Privileges) be amended to read:

- "(1) General Associate Members in this category may attend and speak at meetings of the Association, but not at meetings or portions of meetings relative to collective bargaining. They shall not be entitled to hold office in the Association, nor vote, nor be members of the Executive, except in the case of a retiring President who shall be eligible to serve fully on the Executive in the position of Past-President as an Associate Member for the year immediately following his or her term of office as President.
- (2) Retired Teachers Retired teachers in this category may attend and speak at meetings of the Association, but not at meetings or portions of meetings relative to collective bargaining. They shall not be entitled to hold office in the Association, nor vote, nor be members of the Executive, except in the case of a retiring President who shall be

eligible to serve fully on the Executive in the position of Past-President as an Associate Member for the year immediately following his or her term of office as President. Other privileges may be granted as per Association Policy." and

That By-Law V.B. – Life Membership (Privileges) be amended to read:

"Life Members may attend and speak at meetings of the Association, but not at meetings or portions of meetings relative to collective bargaining. They shall not be entitled to hold office in the Association, nor vote, nor be members of the Executive, except in the case of a retiring President who shall be eligible to serve fully on the Executive in the position of Past-President as a Life Member for the year immediately following his or her term of office as President. Other privileges may be granted as per Association policy."

**Johnson-Veitch:** 

That the motion be amended by adding the words "without voting privileges" after the words "fully on the Executive" in each section of the proposed by-laws.

There was a lengthy discussion on the motion.

**Santos/Stanley-Genge:** That the question be put.

**CARRIED** 

AMENDMENT – DEFEATED

Discussion continued on the original motion.

**Field-Blundon:** That the question be put.

CARRIED

#### D. Resolutions from the Floor

With the concurrence of the assembly, Resolution 2 was WITHDRAWN.

**Goodyear-Stockley:** That the NLTA Collective Bargaining Committee consider for inclusion in the next round of negotiations, a proposal to reinstate sick leave provisions to those that were in place prior to 2006 and that this be done for all teachers.

That the NLTA Collective Bargaining Committee consider for inclusion in the opening proposals for the next round of negotiations a proposal that the first week of school be for teachers only to prepare their classes.

# Resolution 10 -

That the NLTA Collective Bargaining Committee consider for inclusion in the opening proposals for the next round of negotiations a proposal to provide teachers with three days of annual leave to be used at teachers' discretion for promotion of teacher wellness/health.

**Collins-Baker:** That the NLTA policy re Negotiating Team for Provincial

Negotiations be amended to include a specialist teacher (e.g.

Brake-A. Dawe: That the NLTA lobby school districts to ensure that if students

require the use of technology to meet outcomes, the school

district must provide the necessary devices.

Resolution 5 -

**Brake-A. Dawe:** That the NLTA lobby school districts to institute and enforce a

ban on students having/using their own personal electronic

devices in school.

**Adey-Hutchings:** That Resolution 5 be amended to read: "That the NLTA lobby

school districts for a consistent policy on the use of personal

electronic devices in schools."

**Langdon-Short:** That Resolution 5 be referred to Executive.

#### Resolution 7 –

**Blundon-Dwayne Parsons:** That the NLTA investigate the feasibility and

desirability of holding BGM during August instead of

the Easter break.

**Jenkins-A. Dawe:** That Resolution 7 be amended by replacing the word "August"

with the word "summer break".

**Ingram-Drover:** That the amendment be amended to read: "That Resolution 7

be amended by replacing the words "during August instead"

with the word "outside".

**Baker-Way:** That Resolution 7 be referred to Executive.

Following the vote on the motion to refer, division was called. Votes were then counted by a show of hands and the ruling of the chair that the *Baker-Way* motion had been carried was upheld.

Department of Education to include teaching methods for multiage/grade in the program of study documents and curriculum guides provided by the Department of Education.

It was agreed to add the words "and combined grades" after the word "grade".

**Aylward-Collins:** That the NLTA enter into discussions with districts and/or the Department of Education to provide a clear definition of what constitutes a small school.

Resolution 14 –

**White-Jenkins:** That the NLTA consider reserving a pool of surplus funds that branches can apply for to fund alternates to BGM and Joint Council to improve member engagement, such to be discussed at a future Joint Council meeting. CARRIED

Resolution 15 –

**Smith-Dale Parsons:** That the NLTA lobby the Department of Education to have limits placed on the amount of supervision time teachers can be required to do in a given day/cycle.

It was agreed to add the words "and school districts" after the word "Education".
