## **Advisory Motions**

The following advisory motions were discussed and passed at Joint Council for consideration by Provincial Executive:

- That the NLTA lobby NLESD as to the testing requirements for radon gas and air quality in all schools, to provide information as to the number of schools tested and the testing results.
- That the NLTA request the DEECD start the process of determining the emergency supply approval process before the start of the school year.
- That the NLTA work with all necessary agencies to develop a forecasting model for teacher need vs. availability.
- That the NLTA lobby the NLESD to put signs up around the schools, similar to health service signs, which state that teachers are not to be subject to verbal or physical or online abuse from parents/ guardians or students.
- That the NLTA consider for inclusion in the next opening proposals for contract negotiations the creation of a Liaison Committee between the NLTA members and the DEECD.
- That the NLTA investigate the cost and benefit of increasing dental coverage for NLTA members and their families.
- That the Executive review the notes from the Branch President/ Executive break-out sessions, regarding possible extension to

the NLTA building, looking for trends and report back at the next meeting of Joint Council.

Branch Presidents were asked to talk about this within their schools and branches to encourage maximum member participation.
