Other Business

 The Association will endeavour to reach an MOA with the NLESD on the operationalization of Article 6.11 of the Provincial Collective Agreement and Article 42.05 of the Labrador West Collective Agreement that provides timely hiring, transparency in the hiring process and responsiveness to concerns and questions and to provide greater clarification on shortlisting for replacement positions. The President is authorized to sign such an MOA should it be negotiated.
