Professional Development/ Materials Grant

For the third year in a row we are happy to offer a grant to SLP Special Interest Council members. Grant money may be used for professional development or for the purchase of therapy materials. Please read on to learn how to apply by **June 21, 2020**.

The grant to be awarded is a maximum of \$500. Applications will be reviewed by the SLP-SIC executive and eligible applicants will be randomly selected. Please consider the following guidelines:

- Travel, accommodations and registration will be covered up to \$500; the fund does not cover the cost of meals.
- Funds will be awarded when proof of attendance and necessary receipts are received
- Professional development must be in the area of speech, language and literacy, and/or be relevant to school-based speech-language pathologists.
- Applicants must agree to provide a short written summary of what they learned during their professional development. This summary will be shared with our members through our newsletter and social media.
- Funds must be used within one calendar year of the awarded date.

Update on Recommendations #10 and #11

Speaking of the Premier's Task Force, we're sure everyone remembers the recommendations in the report that were especially pertinent to SLPs (see below if you need a refresher)...

- The Department of Education and Early Childhood Development and the Department of Health and Community Services, within one year of the release of this report, develop a provincial child health services model, situated within one government department, to ensure seamless service delivery to schools, continuity of care, and year round access for children and families, and to include: community nursing, speech/language pathology, psychology, occupational therapy and social work.
- The Department of Education and Early Childhood Development and the Department of Health and Community Services review the capacity of social workers, psychologists, occupational therapists, speech language pathologists and community nurses to ensure adequate service to students and families in the new proposed model.

Fortunately (we hope!?) it's been a relatively quiet year for our SIC on this front, with the apparent main focus of the Department of Education and Early Childhood Development (EECD) at this time being implementation of the tiers. In the fall, a company called Optimus Consulting was hired by EECD to further investigate the feasibility and implications of these recommendations. School-based and healthcare SLPs were given opportunities to collaborate with Optimus and give feedback on these important issues, and no doubt we anxiously await a report of the findings.

As an SIC we will certainly keep our membership informed as more information becomes available, but at this point in time we are hopeful that *no news is good news*.

Calling for Nominations

Our SIC currently holds 7 executive positions and are asking for your nominations for new members who might be interested in serving. While each of the titles are listed separately, we've found that roles often overlap — we seem to function well as a team that shares executive responsibilities as needed, so no need to feel intimidated!
