## President's Message

As I write this report, I am grateful that COVID has loosened its grip a little and permitted us to resume some activities in a somewhat more normal way.

The work of our Association has continued uninterrupted on all fronts. Since our last newsletter we have continued to liaise with our member organizations via a combination of Zoom meetings, face-to-face meetings and emails. Through this combination of formats, we have maintained an active and vocal advocacy on issues that concern us as retired teachers and seniors.

Through our membership on the Coalition of Seniors, Retirees and Pensioners we have actively met with both the local Members of the House of Assembly and the local Members of Parliament. We have identified the proposed provisions concerning pensions in the PERT Report as possibly having serious implications for our future retirees. The Coalition has reviewed the Home Care Standards document and made representations to various committees regarding the regulations being proposed as well as the policing of these policies. A more in-depth report, authored by Executive Member Patricia Parsons, on the activities of the Coalition is found elsewhere in this newsletter.

COVID has thrown a real monkey wrench into the planning of events by Memorial University's Faculty of Education to celebrate their 100th Anniversary. The planned "A Time", a symposium to celebrate the history, the contribution to the overall development of the province, the innovations in education, and future of the Faculty has had to be postponed from the Spring of 2022 to the Fall of 2022. The celebratory banquet has also been rescheduled. As part of the initial recognition of the Faculty, the RTANL was invited to have a number of its members take part in a Round Table Discussion focusing on the evolution of teaching over the years. Unfortunately, this Round Table format had to be canceled completely. Instead, the RTANL was invited to be an audience participant during keynote speaker Dr. Gerald Galway's presentation *Reading, Writing and Religion: A Brief*

*History of Teacher Education in Newfoundland and Labrador* on May 4 and a panel discussion on May 5, 2022, *Visualizing Teachers and Education During the Pandemic – the Lessons of Resilience*. We were represented at this event by 25 members from



across the province. Both events were super interesting and well received. Our own plans to commemorate this momentous occasion have also been delayed. The RTANL commissioned a piece of artwork to hang in the lobby of the Hickman Building, but because of the delayed celebrations we have decided to delay the presentation of the artwork to the Faculty of Education to coincide with the official celebrations this Fall.

ACER-CART will hold their AGM in Ottawa from June 2-3, 2022. Vice-President Joe Lafitte and I will attend. Further details of that meeting will be reported in the next newsletter. Last year's AGM was, by necessity, a Zoom format. A report from that meeting is found elsewhere in this newsletter.

Since our last newsletter, the Group Insurance Managers have received and analyzed the results of the survey completed as part of the overall market study of our Health Plan. As a result of that study, changes were made to our plan. All teachers enrolled in the Group Health and Dental plans have been informed of the changes. Starting in May, dental procedures will be reimbursed at 80% of the 2022 Provincial Dental Fee Guide. Additionally, the reimbursement rate for prescription glasses will increase from \$125 every three calendar years to \$175 every two calendar years. In October 2019 a new Regional was formed in Stephenville with great enthusiasm and member support. They have also been under restrictions since that time. President Theresa Dollimount has informed the Division that the Executive will meet on May 20, 2022, to move forward with plans for their next Social. We wish them luck in all their future endeavours.

While being respective of COVID restrictions, Division Executive met on December 9, 2021 to discuss plans for the future. A decision was made to continue with the annual donation to the School Breakfast Program. Since donations had not been made during the restrictions, six schools were chosen in various areas which had not previously received a donation. Each school received \$300. Recipients for 2020 were: Belanger Memorial, Doyles; Canon Richards, Flower's Cove; and J.J. Curling, Corner Brook. Recipients for 2021 were: St. Peter's Academy, Benoit's Cove; Jens Haven Memorial, Nain; and Labrador Straits Elementary, L'Anse au Loup. At the end of that meeting, President Wayne Park announced that he was resigning his position in Western Division as of that date due to personal and family responsibilities. We extend a sincere "thank you" to President Wayne for his contribution to Western Division during his many years of service to our members and wish him well in all his future endeavours.

Prior to an Executive Meeting on March 10, 2022, twelve members of the Division met with the Executive to help prepare the mail out information for the Annual Bakeless Bake Sale for Western Division. Executive members assisted, but then moved their meeting to another area. The remaining members continued to complete the envelope stuffing, adding stamps and address labels and the project was completed. At the end of the Executive meeting, members who had assisted were invited to lunch as a thank you. These members expressed their support for this project and appreciated the opportunity to meet with other members and share lunch together. This project has reaped great benefits

for the Newfoundland and Labrador Retired Teachers' Foundation; all donations received are forwarded to the Foundation. Treasurer Pauline Bishop has advised that to date an amount of \$5,455 has been received and deposited to the Foundation account. Donations are still coming, but are fewer now. A heartfelt "thank you" to all members of Western Division who have, once again, generously donated to their Foundation. This project has been funded by the membership of this Division for many years to assist the Foundation in providing funds for specific children's charities that provide services to Newfoundland and Labrador children. In addition, the Division also makes an annual donation to the Foundation. For the past three years we have increased the donation and presented \$5,000 each year. The donation for 2022 has been approved and \$5,000 will be forwarded to the Foundation.

On May 18, 2022, Western Division Executive met to plan for the Division, moving forward. The meeting was followed by a luncheon with 27 members in attendance. Following the meal, Acting President, Geraldine Wall, shared information that had been discussed earlier at the meeting as well as information pertinent to Division issues. This prompted what turned out to be a great around-the-table exchange of information and discussion. Members were not aware that they needed to notify the Division of any change of address, or the passing of a Division member. These items are forwarded to Provincial Executive who will update the information. Unless we are notified of changes, members may not receive information from their Association to keep them informed. We don't want to add stress for a grieving family by sending mail addressed to their deceased loved one. Many members have indicated they no longer receive their copy of the Newsletter. They were reminded that if you did not request a hard copy of the Newsletter, it is currently distributed electronically and can be received by providing your email address or by visiting the web page. You must request if you prefer a hard copy. Members were reminded that if they have not already done so, and if they wish to attend, it is time to register for the Provincial BGM 2022 which will be held at the Greenwood Inn and Suites in Corner Brook, October 4-6. This promises to be a great celebration for the 50th Anniversary of the Provincial RTANL. Western is the host Division for this event. We hope to see many of you there. The discussion between members and Executive was relaxed and informative, questions were asked, suggestions were offered and concerns for the

future of the Division were expressed. It was a relaxed and informative exchange of ideas. Positive feedback from members suggested they enjoyed the exchange of ideas. It was the type of exchange that could attract more members to attend. Not only was information given, but member dialogue was also acknowledged. No one was in a hurry to leave. That might be a route to explore to improve attendance at future events.

Western Division has always been vibrant and active. During recent years, participation has declined. Not as many new retirees are joining the Association and many who do join do not participate. All but one member of the present Western Division Executive will be resigning at the Division BGM on September 15, 2022. A Nominating Committee has been formed. You can contact any member of the Committee if you wish to nominate a member to serve, or if you are interested in joining the new Executive, you can be nominated as well. Incidentally, November 19, 2022, will also be the 50th Anniversary of Western Division. We are hopeful that we will have a new Executive elected at that time to celebrate the past success of our Division and our hopes moving forward.

On May 4 and 5, 2022 three members from our Division – Geraldine Wall, Lil Critch and Roberta Pafford (two funded by Provincial Executive and one by Western Division) – were able to attend the MUN 100th Anniversary celebrations at The Rooms. Dr. Gerald Galway, Interim Dean of Education gave a presentation on the history of Teacher Training in this province since the early 1800s: *Reading, Writing and*

*Religion: A Brief History of Teacher Education in Newfoundland and Labrador.* It was a most interesting presentation. The following day a panel discussion was held. The speakers, primary teachers Angela Rose and Kim Pelley, (substituting for Joanne Anthony), NLTA President Trent Langdon, Tony Stack, CEO/Director of the English School District, and Dr. Leslie Redmond, Associate Dean, Undergraduate Education, Faculty of Education, discussed teaching during the pandemic. Both events were thoroughly enjoyed, and special thanks are extended to Provincial Executive for this opportunity.

This will be my last Newsletter report. I would like to thank all members of the RTANL for their kindness and support given to me during my involvement in the Association. My journey began in 1996, the year of my retirement, and has continued up to present. I have served Western Division Executive during that time, and I also served on Provincial Executive for a total of 10 years. Anita Finn introduced me to the Retired Teachers' Foundation in 2003 and I have been a Board member up to the present. It's heart warming to see the tremendous growth in the Foundation. I am proud to say that Western Division has been very supportive of the Foundation, helping, with the other Divisions, to make the Foundation the success it is today. I have enjoyed all my experiences that came with membership in this great Association. I visited seven Divisions, and two Regionals as Provincial President. I made many friends and renewed old acquaintances along the way. The RTANL has been a large part of my retirement years. I hope to continue my membership with Western Division and the RTANL well into the future. Thank you all!

# ECRTO Report

The ECRTO Committee met via Zoom on March 10, 2022. It was announced that the ACER-CART AGM would be a face-to-face event in Ottawa on June 2 and 3, 2022.

Funding to branches was discussed. Like the Retired Teachers' Association of Newfoundland and Labrador (RTANL), both New Brunswick (SERFNB) and New Brunswick Society of Retired Teachers (NBSRT) provide rebates to branches – NBSRT \$1 of \$3/month and SERFNB \$12 of \$50/year and there are no local dues, although funds may be raised to support specific activities through such things as 50/50 draws. The RTANL rebates 50% of dues to the Divisions. Quebec (QPARSE) has no branches and most activities that require funds, for example luncheons, are “pay as you go”. The idea of annual dues does come up from time to time. PEI does not rebate to its four regions as things are done locally; however, funds can be provided on request. In Nova Scotia dues are collected by Johnson Insurance, who charge an administration fee. Some Nova Scotia branches collect dues locally, but none of those monies go to the provincial association, meaning those paying local dues get all benefits of the provincial association anyway. They feel that this is a matter needing attention. Although rebates are not provided, \$1,000 grants and \$100 for every 100 members are provided to branches.

Membership Engagement, which is a major concern for all the East Coast Retired Teachers' Organizations was discussed. The results of the AEFNB Membership Survey highlighted the suggested ways in which to engage with their membership. These same ideas were shared by others in the group:

1. Increased visibility on social media.
2. Collaborate with other professional groups.
3. Plan regular review of policies and procedures and seek member input.
4. Survey members to find out what they want and need, thus change goals as necessary.
5. Work to engage/involve branches, the “grass roots”. Some examples might be for local branches to have some of the same committees the provincial organization does and the development of subdivisions within large geographical areas. Also noted was that many do not live in the communities where they taught; hence, there is no/little community connection.

ACER-CART has a number of sub-committees which make regular reports to the Association. The following is a brief synopsis of these reports.

**Communications:** Linda LeBlanc shared that the photo gallery will continue indefinitely, and that the Executive felt now is not the time to pursue a social media presence. The website is typically updated every Friday.

**Advocacy:** Bob Fitzpatrick reported that information about “aging in place” should be released shortly with one-pagers and backup information. Katherine Snow has also been newly added to the committee.

**Health:** Marg Urquhart reported that topics for consideration in preparing the “aging in place” documents to the Advocacy Committee were provided. A series of website “pieces” was submitted, and these will be posted over time. Other considerations are elder abuse, and the need for more “teeth” in the Criminal Code relative to financial abuse. This was also identified by the RTANL. The UPEI survey of seniors is an ongoing work. It was determined the original timeline for participating was too short. This survey examines aging in place and topics included supports, services, transportation. Wayne Denman will share results when available.

Recommendations for Executive Consideration that were presented at the March Meeting were:

1. **Consideration of continued use of hybrid meeting.** Hybrid meetings are expected to become the norm. Those who have participated in such meetings report positively on them. Zoom is still used for many; however, face-to-face meetings are also resuming for some in larger venues allowing for spacing.
2. **Liaison with Seniors Advocacy Groups.** Most of the member organizations of ACER-CART maintain a liaison with the various senior groups in their province. Most noted retired teachers are actively involved in many organizations in their local communities. PEIRTA has members that are “connected” and who give feedback/share information. The seniors' group is always invited to PEIRTA's AGM. NBSRT just appointed a person to the Coalition for Seniors and Nursing Home Residents Rights. They had previously had a representative and have contributed financially for several years. SERFNB participates with the NB Francophone Association of Elders, especially in the

area of Wellness, and belong to the NB Society of Acadians with about 30 other groups. QPARSE is not currently formally involved and getting involved politically is a challenge. The RTANL has two executive members who regularly attend the Coalition of Seniors, Retirees and Pensioners Association meetings. This is our main area of political action. The RTANL maintains an active association with the Teachers' Pension Plan Corporation. NS is part of the Seniors Advisory Council whose members represent 100,000+. Since the fall election, the government representative who used to regularly engage with the group is less available for dialogue.

3. **Special Events.** While special events are not being planned by most, all are looking forward to getting "back to normal"; thus, face-to-face AGMs. SERFNB plans to survey members regarding their feelings about an in-person Congress in the fall. NBSRT noted one of their branches had surveyed members and of those responding, less than half were interested in face-to-face, 30% were not ready and some would hesitantly participate. QPARSE and RTANL have anniversaries this year and plan special events.
4. **COVID.** PEIRTA noted COVID is still having a significant impact in schools and thus nothing is being planned at this time. The concern around COVID, given the age grouping of our memberships, was echoed by all in attendance.
5. **AGM/BGM.** QPARSE will hold an AGM, as will NBSRT and NS, while RTANL will hold a formal BGM.

Every provincial association has identified some high points for the coming months.

QPARSE will celebrate their 60th Anniversary. The celebration will feature speakers from over the years and the hope is to have a photographic history. There will also be a recognition of Special Service Awards including those that have not been done in person due to COVID. The facility will allow for distancing and provide for outdoor socializing with no meal. Zoom sessions have been so successful and brought in people not otherwise participating in events so they will continue in 2022-23 with social events being in person.

QPARSE looks forward to the October 19th and 20th in-person meeting of the ECRTO and will have a full day on the 19th and half day on the 20th. Attendees felt a list of things one could do on their own, should they wish, the afternoon of the 20th would be helpful; however, QPARSE did not need to plan something for

then. Membership, and various facets of it, will be a key topic and plans are for two roundtable sessions and ideas for speakers have been considered.

NS's pension has an unfunded liability, and the pension reform report is expected in June. RTO is participating in the review. They are also participating in a mail out, with their input, to all retirees through the group insurance trustees in April.

RTANL will celebrate 50 years this fall and plan a special newsletter to commemorate the event. To celebrate 100 years of the Faculty of Education we have commissioned a painting. We are, as well, looking at cessation planning as our membership is getting older and the numbers joining the RTANL upon retirement are not near the numbers we are losing due to natural attrition.

NBSRT has offered two webinars and anticipates more as interest was high and included retired teachers who are not NBSRT members. An open Facebook page has been set up in addition to the long-standing closed Facebook group.

It was noted that several jurisdictions have signed supplements to the Bilateral Health Accords relative to Long-Term Care Funding. NB's government seems to be saying the right things. Nova Scotia now has a Minister of Seniors and Long-Term Care. Their Seniors Council has some concerns including dedicated funding and in-home care. The RTANL has identified that the Long-Term Care Standards do not have compliance obligations embedded in the document. Furthermore, in many cases the standards are vaguely written and are not measurable.

The Retired Teachers of Ontario noted the Wellness Symposium helped focus Branches that the experience of current members needs to be enriched, programs need to be revamped/reviewed and younger retirees want active programming. They must ensure an information package is given to new retirees and posters placed in every school. They feel there needs to be consideration of early, mid and late retirement members as well as male and female in planning programs. New Brunswick Teachers' Association (NBTA) cooperated with the New Brunswick Society of Retired Teachers, in sending invitations and applications to retirees both at the end of the year and this past Christmas to all retirees in the last three years. They support the retired teachers of their province, in other ways – financial, provide meeting space, and the newsletter.

Face-to-face meetings are preferable as long as there is consideration of such precautions as spacing and masks are acceptable. NBSRT noted one branch did a survey and less than half of respondents were interested in face-to-face at this time. Over half would attend with hesitation. SERFNB plans a survey to see if members would attend the fall Congress in person.

There is no anticipated need to meet prior to the ACER-CART AGM. Attendees were reminded to consider and encourage those who might offer themselves as the East Coast Representative.

Gerry Tiede, President of ACER-CART thanked the Members for the invitation and noted he had learned a lot during the course of the meeting.

## ACER-CART Report

On Friday, June 4, 2021, myself as a Director, and our Vice-President Joe Lafitte, as an observer, virtually attended the Annual General Meeting of the Canadian Association of Retired Teachers. All 10 provinces, plus the Yukon, were represented.

Like many organizations, the executive of the Canadian Association of Retired Teachers agreed to an extended term of office due to the limitations posed by the pandemic. Continuing in their positions will be: President, Gerry Teide; Vice-President, Martin Higgs; the regional representatives will continue to be Margaret Urquhart for Eastern, Martha Foster for Ontario, and Marilyn Bossert for Western. Remaining on the Executive will be Past President, Bill Berryman and Executive Director, Roger Regimbal.

This AGM reaffirmed the prime goals for which ACER-CART will advocate in the coming year as:

1. Advocate for the development and implementation of a National Seniors Strategy including using the information from “A Declaration Concerning a National Strategy for Seniors”.
2. Monitor the Federal Government’s implementation of a universal pharmacare program including the establishment of a Canada Drug Agency and implementation of a national formulary.

3. Monitor effects of COVID-19 on the Canada Health Act and on the Bilateral Funding Agreements with the provinces and territories.
4. Advocate for a healthcare system that prioritizes care in seniors’ own homes for as long as possible.
5. Advocate for regulations governing Retirement and Long-Term Care Homes with emphasis on improving patient respect, working conditions, staff training and staff wages.

ACER-CART will continue to monitor the effects of the global pandemic and defined benefit pension plans assets and liabilities as solvency funding applications could be affected. A change in pension plans in one group could signal a change in other pension plans down the road. ACER-CART is always cognizant of the importance of our pension plans and their defined benefits to our membership.

The AGM for 2022 will take place on June 2-4 in Ottawa. A report on that meeting will be published in our December Newsletter.

# Retired Teachers' Foundation

I'm sure most of you are aware that the RTANL has its own charity – the Retired Teachers' Foundation (RTF). You've seen its reports in Newsletters and you've heard members talk about it in meetings and maybe in conversations, but how much do you really know about the Foundation?

The RTF was set up in 1983 by the Central Division to honour the life and work of all retired teachers. It is a Canada Revenue Agency regulated children's charity with funds raised being given to institutions and groups that provide medical treatment and/or educational training for children who are incapacitated. The funds are generated by annual lump sum donations from our Provincial RTANL and its eight Divisions, individual donations from members and friends, and In Memoriam donations for deceased members. Some Divisions fundraise and donate the proceeds to the Foundation, others have elected to donate money from their share of member fees, and some do both.

Since the 1994 BGM, the RTANL has been sponsoring the Foundation, and all Divisions play an active role in supporting its mandate. The provincial body covers any expenses incurred by the Foundation (stationary, postage, travel for meetings, etc.), since all funds raised by the RTF are given to charities. The Foundation is run by a volunteer board of retired teachers. Prior to 2018, the board was elected at each BGM, with members coming from all over the province. At the 2018 BGM, it was proposed that the board be made up of volunteers from a particular Division, to make it easier for members to get together for meetings and, as well, to save on travel costs. Western Division volunteered to take the reins, followed by Con-Tri Division in 2021. At the 2022 BGM we will be looking for another Division to take over the running of the RTF. If anyone in your Division would be interested in taking on such a role, please let President Sharon Penney know and she can get you the information you would need to form such a committee. Five people would be needed for the board.

Since 1987 the Foundation has donated approximately \$462,250 to children's charities in our province. Our recipients are registered charities, and the Foundation assists them in reaching their goals. To avail of these donations the charities must apply to the Foundation and meet the selection criteria that are in place. Some of the charities that have benefited from our donations in recent years are the War Amps CHAMPS program, Down Syndrome Society, Canadian Diabetes Camp Douwanna, CNIB Youth Orientation Program, Mazol Shriners for the Patient Transportation Fund, Rainbow Riders, and the Candlelighters Camp Delight.

If you wish to donate in memory of a retired teacher, or anyone for that matter, you will be given a tax receipt and, if you wish, the family of the deceased will be advised of your donation. Donation cards should be available at funeral homes; your Division President should also have some on hand, or can arrange to get some, if you wish to donate.

The RTF has another role, that of managing the *Books of Remembrance*. The Books of Remembrance were made to commemorate the lives of deceased retired teachers. A memorial page is dedicated to each teacher and contains biographical information, and a photo, provided to the Foundation by the family of the deceased teacher. At present there are six of these books, which are arranged chronologically by year of death. Book One: 1986-1998, Book Two: 1992-2000, Book Three: 2001-2006, Book Four: 2000-2010, Book Five: 2005-2010 and Book Six: 2018-2021. The Books are housed at The Rooms in St. John's, in the Provincial Archives Division. If sometime you are visiting The Rooms, you can have a look. Since 2018, all submissions have been recorded for online viewing as well. # RTANL and the Coalition

The Seniors Coalition continued its advocacy for seniors with a follow-up meeting with Minister John Abbott in December 2021 (from a previous meeting in May) to monitor his department's commitment to seniors' issues. This was followed by a virtual meeting in January 2022. This last meeting centered on the Building Accessibility Act. After a group discussion, the following points were identified as important:

- The Act said that buildings built before 1981 were to be exempt from the Act. The Coalition recommended that this exemption be removed from the Act.
- Tax exemptions would be made available to businesses and property owners to ensure compliance to the Act.
- There would be an increase in fines to ensure compliance.
- Name changes for the Act.
- Minimum standards for buildings be embedded into the Act for all buildings going forward.

The Coalition will write letters to Ministers John Hogan and John Abbott about amendments to the Criminal Code re Elder Abuse, reminding them of the Coalition's commitment to this issue. The Coalition also wrote letters to Ministers Sarah Stoodley and John Abbott about the many government services now offered online. There is a concern that online government services are an issue for many seniors who may not have access to technological devices. They ask the government to do all it can to ensure no senior is left behind due to technology. A meeting will also be requested with Minister John Haggie to discuss seniors' issues such as pharmacare, vaccinations other than COVID-19 and availability of rapid tests, to name a few.

The Premier's Economic Recovery Team (PERT) Report was discussed at a meeting of the Coalition. It was felt the report glosses over many concerns of seniors and doesn't commit to any particular approach. It was felt we must remain cognizant of the government's long-term plans for pensions, both those in effect today and those going forward. The Coalition will respond to this report encompassing The Pensions Act and the implementation of the Health Accord.

The Coalition continues to monitor the national Standards for Long-Term Care and recently engaged in a

comprehensive review of the plan. It was concluded there were many shortfalls including no mention of family involvements, no way to measure implementations and no one to do it, and no mention of quality of care. There is an online response form to this draft and two Coalition members agreed to write a response to the report on behalf of the Coalition and fill out the online response form.

The Newfoundland and Labrador Public Service Pensioners' Association (NLPSPA) is in the process of updating their website. They have invited the Seniors Coalition to have a home base on their website. It was decided to accept this offer. It would provide a place for the Coalition to house their documents and information as well as provide links to member organization's websites.

In separate Zoom meetings in January 2022, the Coalition met first with the Federal Liberal MPs and then with Federal Conservative Member Clifford Small. The Coalition reviewed a Letter of Intent previously sent out to the MPs which pointed out senior issues the Coalition is wishing to keep in the forefront. Being a new MP, Minister Small was made aware of these issues and agreed to advocate as much as possible for seniors. The Federal Liberal MPs discussed some senior initiatives they are presently engaged in and pledged to advocate for seniors whenever the opportunity arises.

The Coalition met with Consumer Advocate Dennis Browne over Zoom in January as well. The moderator indicated in her introduction that one of the main issues many seniors are facing today is the rising cost of living. Many people are struggling to make ends meet and to make sensible choices when they shop. Mr. Browne explained his role as a Consumers' Advocate. This position is one of a rate payer advocate and he represents consumers about rate paying and rate increase applications by NL Hydro and NL Power to the Public Utilities Board. From a Coalition perspective, it was hoped amendments to the Public Utilities Board would be enforced. Mr. Browne agreed to keep the Coalition informed of any developments in change of legislation. He also pointed out that we, as members of the Coalition, can also be the eyes and ears of any hearings.

# Group Insurance Managers' Report

A Group Insurance Managers meeting was convened via Zoom on November 6, 2021. The purpose of the meeting was to discuss Funding Policy, Training and Education, and Deeds of Trusteeship. Using the rotation for additional training and the schedule that was determined in 2020, it will be the RTANL representative who will receive the next training that becomes available.

The Group Insurance Managers met in the Zoom format on November 24, 2021, There was only one item on the agenda. The meeting was called to finalize the wording of some recommendations to the NLTA Executive.

At our meeting on February 12, 2022, we discussed *Mind Beacon*. This is an online mental health program that is being considered for inclusion in our program. During April we were given access to *Starling Minds*, another online mental health program. We are looking at including this type of program in our offerings as it is hoped an online mental health program would alleviate some of the delay caused by a shortage of therapists and deal with the COVID backlog. Both programs were discussed as part of our oversight of the plan.

The meetings in February dealt with the Market Study we commissioned to review our Health Programs. The objectives of the Market Study were to:

- 1) Assess the competitiveness of the existing rate structure, retention expenses and pooling charges.
- 2) Assess the competitiveness of the current benefits and levels of coverage.
- 3) Obtain costings on alternate benefits and levels of coverage.
- 4) Ensure that the policy provisions meet current industry standards.

As a result of the Market Study, the following decisions were made regarding which company would be providing different parts of our overall plan:

Two items of note were a direct result of the Market Study. Members were adamant that there not be changes to the paramedical components of our program and that the provisions for eye care be increased. Eye care will now be provided at a rate of one new pair of glasses every two years and rebated at a rate of \$175 every two years.

I attended a Group Insurance Zoom meeting on February 23, 2022. At this meeting a discussion took place regarding the Medoc Travel Insurance. It was decided that Johnson Insurance would continue to supply this portion of our overall insurance options. It was affirmed that Manulife would continue to provide our Long-Term Disability component.

At every meeting we review the usage of the health plan, dental plan and the long-term disability plan to monitor the costs of this to our overall plan.

At the May 28, 2022, meeting various online mental health programs were reviewed. It will be discussed further in the hopes that we can add such a feature to our plan.

We say good-bye to Darrin Pike as he retires from the NLTA, and hello to John Veitch, his replacement. Darrin has been a great source of knowledge and support during his tenure at the NLTA. We look forward to a continued collegial and supportive relationship with Mr. Veitch.

# Proposed Changes to Constitution and By-Laws

The following are some proposed changes/additions to The Constitution and The By-Laws as proposed at the Provincial Executive meeting on April 28, 2022. These changes will be voted on at BGM 2022 in October.

## Changes to The Constitution

### ARTICLE VIII: PROVINCIAL EXECUTIVE

**Rationale:** The Provincial Executive feels that some changes made to The Constitution at BGM 2018 are overly restrictive. Any member of the Provincial Executive should retain the right to resign from office if personal situations warrant such action. Furthermore, the Provincial Executive feels it is not a viable option to elect an alternate Member-At-Large at a BGM and expect that person to “wait in the wings” so to speak in case there might be a resignation (vacancy) on Provincial Executive.

Whereas the election of an Alternate Member-At-Large at a BGM now requires that Alternate wait 12 months before holding office while the Immediate Past President completes their Term of Office for ONE year;

And whereas such duly elected Alternate might not be interested in such a waiting period;

BE IT RESOLVED that the following changes be made to our Constitution:

#### Current Wording:

### ARTICLE VIII: PROVINCIAL EXECUTIVE

- A. The Provincial Executive shall consist of: President, Vice-President, Immediate Past President, [By-Law Article VII: A (4)], Secretary, Treasurer, and four (4) or five (5) Members-at-Large [By-Law: VII: A.], provided that there are not more than three (3) Members of the Executive from any one (1) Division and that the total Executive Membership shall not exceed nine (9).
- B. The Members of the Provincial Executive, with the exception of the Immediate Past President, shall be elected at the Biennial General Meeting (BGM) of the Association for a term of two (2) years.
- C. Election of the Provincial Executive shall be by secret ballot.
- D. Any vacancy occurring among the members of the Provincial Executive of the Association, through any cause, shall be filled by the Provincial

Executive from the Alternate Members provided under By-Law Article III (G), in order of the number of votes received, provided that there are not more than three (3) Members of Provincial Executive from any one (1) Division.

**Proposed Wording:** *(To read as was prior to BGM 2018)*

### ARTICLE VIII: PROVINCIAL EXECUTIVE

- A. The Provincial Executive shall consist of: President, Vice-President, Immediate Past President, Secretary, Treasurer, and four (4) Members-at-Large, provided that there are not more than three (3) Members of the Provincial Executive from any one (1) Division and that the total Provincial Executive Membership shall not exceed nine (9).
- B. The Members of the Provincial Executive, with the exception of the Immediate Past President, shall be elected at the Biennial General Meeting (BGM) of the Association for a term of two (2) years.
- C. Election of the Provincial Executive shall be by secret ballot.
- D. Whenever a vacancy occurring among the members of the Provincial Executive of the Association, through any cause, the Provincial Executive shall name an Active Member of the Association to fill the vacancy until the next BGM provided that there are not more than three (3) Members of Provincial Executive from any one (1) Division, provided that the appointment adheres to Item A of this Article.

Whereas all Members to the Provincial Executive work for the common goals of the RTANL regardless of their Division;

And whereas many Divisions are having difficulty attracting Members to run for office on Provincial Executive;

And whereas the “no more than three (3) from any one Division” rule could potentially be a hindrance to obtaining a full Provincial Executive at BGM, the Provincial Executive is recommending the removal of the words: **“provided that there are not more than three (3) Members of the Executive from any one (1) Division”** from The Constitution, Article VIII. A.

---

## Addition to The Constitution

### ARTICLE X: WINDING UP OR DISSOLUTION OF RTANL

If/when the Retired Teachers' Association of Newfoundland and Labrador (RTANL) is unable to form or maintain a Provincial Executive, a motion must be presented and voted upon by delegates at the next RTANL Biennial General Meeting (BGM) to dissolve the RTANL. If this situation arises during a non-BGM year, the motion to dissolve the RTANL must be presented and voted upon during a meeting of the current RTANL Provincial Executive when a quorum is present. A motion to dissolve the RTANL shall require a simple majority approval (50% + 1) to be carried.

If, upon dissolution of the RTANL, and after the satisfaction of all debts and liabilities, any funds remain in the RTANL account(s), said funds shall not be paid or distributed among the members of the RTANL, but shall be donated to one or more registered charities whose primary goal is to support and advance the rights and well-being of children. For greater clarity, any such funds must be donated for the purpose of supporting and advancing education and/or well-being for children with disabilities or children who have a mental or physical illness.

## Changes/Additions to The By-Laws

Whereas Gander is the Central location for the Island of Newfoundland;

Whereas most of the RTANL members who attend BGM are seniors;

Whereas the price of gasoline continues to increase;

Whereas many members, because of the distance, spend a night in Central NL along the way;

**BE IT RESOLVED that beginning in 2024 and continuing thereafter, ALL RTANL BGMs be held in Gander.**

### ARTICLE I: QUORUM

Whereas the number of RTANL members attending the BGM continues to decrease:

**BE IT RESOLVED that the current By-Law Article I: Quorum be amended:**

### Current Wording:

#### ARTICLE I: QUORUM

- A. At the Biennial General Meeting and at Special/Emergency Meetings (either in person or virtually), a majority of the Provincial Executive plus twenty-five (25) Active Members who attend, having been given at least thirty (30) days notice, shall constitute a quorum.
- B. At Provincial Executive Meetings, a majority of the Executive Members shall constitute a quorum.

### Proposed Wording:

#### ARTICLE I: QUORUM

- A. At the Biennial General Meeting and at Special Meetings (either in person or virtually) **thirty (30)** Active Members including a majority of the Provincial Executive, having been given at least thirty (30) days' notice, shall constitute a quorum.
- B. The deadline for Registration for any BGM shall be the end of August of the BGM year. This will allow for cancellation of the BGM should a Quorum not be met. Following a cancellation, a second call for a BGM with at least thirty (30) days' notice shall be given. **A Quorum shall then constitute the number of Active Members present.**
- C. At Provincial Executive Meetings, a majority of the Executive Members shall constitute a quorum.

#### ARTICLE III: ELECTION OF PROVINCIAL EXECUTIVE

### Current Wording:

- G. Ten (10) Provincial Executive members shall be elected biennially, and the four (4) who have the greatest number of votes shall with the President, Vice-President, Secretary, Treasurer and a person holding office under [By-Law VII A 4], where applicable, form the Provincial Executive and that the total Provincial Executive Membership shall not exceed nine (9). The remaining elected members shall be classified as Alternate Members.

### Proposed Wording:

- G. Eight (8) Provincial Executive members shall be elected biennially, namely: President, Vice-President, Secretary, Treasurer, and four (4) Members-At-Large PLUS the Immediate Past President, provided the total Provincial Executive Membership shall not exceed nine (9).

## ARTICLE VII: DUTIES OF OFFICERS

### Current Wording:

4. Upon the election and swearing in of a new President, the Immediate Past President shall serve as an ex-officio Provincial Executive member for the first year of the new President's term of office.

### Proposed Wording:

4. Upon the election and swearing in of a new President, the Immediate Past President shall serve as an ex-officio Provincial Executive member. *(removing the phrase "for the first year of the new President's term of office")*

# Glaucoma: The Silent Thief

The optic nerve is the nerve that transmits information from the eye to the brain. Elevated pressure within the eye damages the optic nerve. This damage, if not detected and treated early, can lead to serious vision loss.

Glaucoma refers to a family of diseases that damage the optic nerve; it is one of the leading causes of blindness in Canada. Glaucoma is a progressive disease that most frequently affects individuals over the age of forty, with the risk of the disease increasing with age. People with diabetes, high blood pressure, a history of eye diseases or a family history of glaucoma are at a higher risk to contract this disease.

Open angle glaucoma, the most common form of the disease, presents no symptoms until an individual experiences peripheral vision loss. Because of this lack of symptoms, glaucoma is referred to as 'the silent thief'. In a rarer form of the disease, closed angle glaucoma, there is a sudden rise in pressure within the eye and the individual may experience pain, blurred vision and see halos around lights. Left untreated, both forms can lead to complete loss of vision.

There is no way to prevent glaucoma; a comprehensive eye examination with your Doctor of Optometry is the only way to detect the disease. Even if you see well or don't wear glasses, regular eye exams help detect glaucoma and other diseases early enough to prevent vision loss. To test for glaucoma your Optometrist will perform a simple and painless procedure, during your routine eye exam, which will measure the internal pressure of your eye. They will also look into your eye to observe the health of the optic nerve and measure your field of vision.

If glaucoma is detected and treated early, eye drops, and laser surgery are usually effective at maintaining your vision and little or no further vision loss should occur. If it is left untreated, peripheral vision will be affected first, followed by central vision loss during the late stages of the disease. Complete blindness may occur. Special equipment may be used by your Optometrist to image your eye to better monitor the progression of glaucoma.

## New Department of Education Pre-Kindergarten Pilot Program

# Teachers' Pension Plan Designation of Beneficiary


Under the former Act, a plan member could only name a beneficiary if they did not have a Principal Beneficiary, a dependent child or another dependent and then only if the named beneficiary was dependent upon the member for financial support. Upon the death of a member with no principal beneficiary, any death benefits would be paid to the plan member's estate, with no option for the benefit to be paid to a named beneficiary. This could potentially have negative financial implications for the member as the member's estate is subject to tax and accountable to creditors. Payments to a designated beneficiary would mitigate these considerations.

Section 7 of the Plan Text now provides that a plan member may designate a beneficiary to receive a benefit payment. A separate communication was mailed to all plan members outlining all necessary actions to be taken in order to designate a beneficiary.
