Again, I remind you, your voice is important to us. Make it heard by contacting your Division President or other voting

delegates to express your opinion on matters of the Association such as this, which will be decided by vote, at our Biennial General Meeting/Reunion, October 2 - 4, 2018, at Holiday Inn, St. John's. We would love to see as many of you as possible join us for this event.

There's plenty of information about it in this Newsletter. Please give some thought to attending. It will not disappoint!

Constitution and By-Laws:

The Board has been examining the Foundation's Constitution and By-Laws. We are recommending the following amendments which will be voted on by the membership at the BGM in October.

Constitution:

Article V: Powers

1. SubSection 6: Moved by Tom Kendell and seconded by Doreen Noseworthy. Remove word "establish". Insert "Continue to compile" subject to the approval of our Sponsoring Body, Books of Remembrance. (Carried)
Rationale: update wording.

By-Laws:

1. Article II: Membership

SubSection 2: Moved by Anita Finn and seconded by Doreen Noseworthy. Delete article "Associate Members". (Carried).
Rationale: confusing and not needed.

2. Election of Directors

Subsection "e": Moved by Agnes Hughes and seconded by Lil Critch that wording be changed to "The term of office of the Chair shall be for a two-year term from October/BGM in the year the Chair was elected to the October/BGM of the second year following.

SubSection "f": Moved by Agnes Hughes and seconded by Lil Critch. Change to "The office of the Chair shall not be held for more than two consecutive terms (four years in total). (Carried)
Rationale: provides for change.

SubSection "g": Moved by Agnes Hughes and seconded by Lil Critch, that "The Immediate Past Chair shall serve for the first year only of the new Chair's term of office." (Carried)
Rationale: cost effective.

3. Duties of the Officers

Add subsection "V", Past Chair

Moved by Tom Kendell and seconded Lil Critch, "The Immediate Past Chair shall serve as an ex-

officio member of the Board of Directors for the first year only of the new Chair's term."

Rationale: This would allow for continuity and consistency of the Foundation's business and support the new Chair. Also would provide for more cost effectiveness.


4. Meetings of the Board

Teachers' Pension Plan Corporation Introduces Website

The Teachers' Pension Plan Corporation (TPPC) was established on September 1, 2016 in accordance with the Pension Reform Agreement between the Government of Newfoundland and Labrador and the NLTA representing plan members. The Agreement was ratified through a province-wide vote of teachers with over 90% approval. The governance structure and the roles and responsibilities of the TPPC are detailed in the Joint Sponsorship Agreement (JSA) at www.nlta.nl.ca/wp-content/uploads/2017/08/Joint-Sponsorship-Agreement-2016.pdf.

The TPPC is now responsible for investment of the Teachers' Pension Plan Fund and the administration of the Plan and its office is located at 130 Kelsey Drive, Suite 101, St. John's. The transition from the Pensions Division, Government of Newfoundland and Labrador, to the TPPC, although seamless to plan members, has been the result of a tremendous amount of work on the part of the Plan Sponsors, the Board of Directors, and the staff of the TPPC.

We would particularly like to draw your attention to the newly created TPPC website www.tppcnl.ca. The website has a section designed specifically for pensioners and includes forms and information which a pensioner may require. The TPPC Annual Report can also be found on the website (www.tppcnl.ca/AboutUs/AnnualReports). The website is still a work in progress with the ultimate goal to enhance the website so that individuals can access their personal pension information. While that is a considerable ways down the road, the introduction of a website dedicated to the TPP is an indicator of improved service that pension plan members can anticipate now that the TPPC has responsibility for administration of the plan.

The TPPC Board of Directors and the staff of the TPPC will continue their efforts in the best interests of the Teachers' Pension Plan.

Retired Teachers Honoured at NLTA BGM 2017

Three retired teachers who have made significant contributions to the teaching profession were recognized at the NLTA's Biennial General Meeting in April 2017. The following information has been reprinted from the NLTA's Post BGM 2017 Issue of *The Bulletin*.

NLTA Honorary Member – Doreen Noseworthy

Doreen Noseworthy was made an honorary member of the Newfoundland and Labrador Teachers' Association during the Association's Biennial General Meeting in St. John's on April 19, 2017. Doreen joins a group of 44 distinguished Newfoundlanders and Labradorians who have received this honor.

Doreen attended St. Patrick's Convent School from 1951 to 1960, graduated with honours from Holy Heart of Mary Regional High School in 1963 and attended MUN from 1963-64. Several years later she resumed her studies at Memorial University and graduated with her B.A. (B.Ed.).

Doreen began her teaching career at St. Patrick's Convent School in 1964, where she taught for 15 years. She took leave when her son was born and opened a Pre-Kindergarten Nursery School in her home in Holyrood, which she operated for five years. When her children began school, Doreen returned to teaching, substituting in schools all around Conception Bay Centre, CBS, St. Joseph's and Mount Carmel for quite a few years. She retired in 2003 from St. Catherine's Academy in Mount Carmel with a career in education that spanned 38 years.

Doreen has been an advocate for teachers/educators and students all her life, beginning with her early involvement as Newfoundland Teachers' Association (NTA) School Rep for St. Patrick's Convent School. As a pre-school teacher she joined the Early Childhood Development Association. As time went on, she became involved with the Conception Bay South Branch of the NLTA as Communications Officer, Vice-President and President. She also served on several provincial committees – Substitute Teachers' Ad Hoc Committee, Communications/Political Action Committee, and the Committee on Communications Between Branch Presidents and Provincial Executive. Doreen was elected as a member of the NLTA Provincial Executive in 1994. During a particularly difficult round of negotiations, she wrote and delivered a speech on the steps of Confederation Building at a province-wide teachers' rally organized by the NLTA on the topic, "I Touch the Future, I Teach".

Before retiring in 2003, Doreen was elected Vice President of the Avalon East Division of the Retired Teachers' Association of Newfoundland and Labrador (RTANL). She served two years as Vice President, four years as President, and two years as Past President. She also served at the provincial level of the RTANL as a Member-at-Large and Vice President. In these positions she oversaw all activities, events and functions of the Division and as President, represented the RTANL and the Division at retirement banquets and attended and presented at many pre-retirement seminars on behalf of the RTANL. She was a member of the Finance Committee, Newsletter Committee, an observer and director at ACER-CART AGMs, Chair of the RTANL Reunion and BGM Committee for 2012, member of and currently chairperson of the RTANL Liaison Committee with the NLTA, and serves as the RTANL Rep on the Group Insurance Managers Committee, finishing her seven-year term in May 2017. She is currently serving as President of the Provincial Executive of the RTANL.

In her retirement, and as a representative of the RTANL, Doreen was asked to serve as a member of the Provincial Aging Issues Network established by Government through the Seniors Resource Centre. The purpose of this group was to research and identify the main issues of seniors living in the province of Newfoundland and Labrador. She also served as a member of the Coalition of Public Pensioners of NL. This organization subsequently became the Coalition of Pensioners, Retirees and Seniors of NL, of which Doreen now serves as secretary.

Doreen was told she began to sing as soon as she learned to talk. In fact, her parents were never sure which came first. She used to play her dad's guitar but he would have to hold it for her since it was much too big for such a little girl. Her singing and playing as a child turned into a second career as manager and lead vocalist with "The Montereys" dance band from 1965-75. The band played all over the Avalon region of the province performing at night clubs, private dances, garden parties, weddings, Christmas parties and the like. They were very much in demand and Doreen stayed with the band until February 1975 when, being four months pregnant with her first child, she decided it was time to quit.

Doreen continued with her playing and singing over the years at local concerts, a little pub work now and then, substitute teaching for music teachers and being

involved with musical events in the Conception Bay Centre area. She was Music Minister and Leader of Song with Holy Cross Church in Holyrood for approximately 20 years and is currently a member of the Cloudberry Community Choir and Holy Cross Church Choir. For the past number of years she fills her summers with music and song at the H.W. Duffet Shriners' Park in Eastport with two nights of music each week and a Gospel Sing every Sunday morning, as well as appearances at the Heritage Theatre in Eastport.

When her daughter was taking art lessons, Doreen was so amazed and interested by what she was doing that, when a space became available in the class, Doreen signed up. She started out working with oils and, a few years later, switched to acrylics. She is continuing with her lessons; however, has recently offered some prints for sale. While she doesn't consider herself an "artist", she feels that if people like her work, why argue with that. Her paintings can be found on Facebook as "Newfoundland Artist Doreen Noseworthy".

Doreen has served on Pastoral Council and the Executive Board with Holy Cross Church, has been a member of the Marriage Preparation Facilitators' Team, served as a member of the Parish Council, Chairperson of the Liturgical Committee, Girl Guide Leader, and has organized and participated in local events and fundraisers, including Holyrood's Annual Squid Jigging and Folk Festivals, Children's Fun Days and other community events.

Doreen was Formation President of the Conception Bay Centre Kinette Club and Zone 9 Kinette Coordinator, Founding Member and First President of the Conception Bay Centre Kinette Club, and was awarded the District 7 Kinette Diamond Award for Outstanding Service.

Why We Need Universal Pharmacare¹

The call for a universal pharmacare program is a call to finish the business of our Canadian Medicare program, begun over 50 years ago through the vision of Tommy Douglas. Since the 1960s, several studies on Canadian Medicare have recommended including prescription drug coverage, most notably the Hall Commission in 1964, the National Forum on Health in 1997, and the Romanov Commission in 2002. Since then, organizations such as CARP, the Canadian Labour Congress, Federal Retirees, Canadian Medical Association, Canadian Health Coalition, Council of Canadians, and ACER-CART (just to name a few) have continued the call for a universal pharmacare program. Yet, Canada remains the only developed country in the world with a universal health care program that **DOES NOT** include a universal prescription drug plan.

One in ten, or 3.5 million, Canadians are not taking the medication they need as prescribed because of the cost, affecting one in five households. Many are splitting their pills, skipping days to stretch their prescriptions, sharing their medicines, or going deep into debt to pay for them. This has serious implications for peoples' health and additional costs to our health care system.

Our multiple-payer system has resulted in the second highest prescription drug costs in the world next to the United States. Our patchwork prescription drug system is inefficient and expensive, leaving many Canadians with widely varying coverage and uneven access to prescription drugs, often resulting in people paying different rates for the same medications.

If Canadians are not benefiting from the current system, then who is? The answer is simple. Pharmaceutical companies can charge higher prices for commonly used drugs because they are selling to so many buyers. Private insurance companies benefit by charging employers, unions, and employees to administer private drug insurance plans. In New Zealand, for example, where there is a universal pharmacare plan, Lipitor (a cholesterol busting drug) costs just \$15 a year; in Canada, it costs \$811. Amlodipine, a common blood pressure medicine costs \$130 in Canada and only \$10 a year in New Zealand. A year's supply of Amoxicillin, the generic antibiotic made by Apotex (Canada), costs \$32 in New Zealand and almost \$200 in Canada or 500% more. Something is seriously wrong with this picture.

We know now that the topic of universal pharmacare will be a federal election issue in 2019. The Liberal party has already made statements about establishing a National Pharmacare plan before 2019, yet shortly after the 2018 federal budget, we have seen messaging from the Minister of Finance to the Economics Club of Canada that he merely plans to fill the gaps to Canada's existing patchwork of private and public drug plans. Patchwork measures are not enough. We need this government to commit to a national publicly administered universal prescription drug plan for every Canadian, in every province and territory. An annual investment of \$1 billion by the federal government will mean Canadians save \$7.3 billion on the medications they need. There can be no argument with this math. If the party currently holding power is truly committed to establishing a universal pharmacare program, there is no need for more research or consultation. It does not need to be an election promise. It can be done now, and **THEY CAN DO IT!**

Other parties also seeking your vote in lead up to the next election will no doubt be promising a pharmacare plan and this is where we all, together, need to hold every politician, or would be politician, accountable. Call your MPs, write letters, demand the plan now, speak to our provincial MHAs and tell them you want them to lobby the federal government for this plan, and sign petitions. Do not be misled by rhetoric of cost or corporate impact. The louder our voice, the greater and sooner a pharmacare plan will be in place.

Our power is at the ballot box. It is important that you be knowledgeable of this issue and when you are visited at home or online by those seeking your vote, you ask what their position is on the establishment of a universal pharmacare program. Use the power of the election vote to make change that will positively impact all our lives.

What Has the Seniors Coalition Been Doing?

Vision, Unity, and a Stronger Voice: The Newfoundland and Labrador Coalition of Seniors', Pensioners', and Retirees' Associations and Groups was officially re-branded and re-launched in April of 2014, having been around since 2008. Known as either the "Seniors Coalition" or the "Coalition", there was little support initially for the issues being addressed, as the Coalition was publicly perceived to be representing only those pensioner organizations that had a former union related employment history. The Coalition recognized that concerns of retirement security, health outcomes, and social engagement were common to all participating associations and that by consolidating these into a single voice while preserving the original purpose and activities of each participating organization, their capacity to advocate on matters that challenged the well-being and quality of life of all aging persons in Newfoundland and Labrador, in particular, and in Canada generally could be better impacted through unity and collaboration.

So, what are some of the common issues that are so critical to the organizations participating in the Coalition? Understandably, health care is at the top of the list, and ranges from availability of medicines and a person's ability to pay for them; dispensing fees charged by pharmacies; wait times to see a doctor, especially if there is a referral to a specialist; distance to travel for hospital care; costs associated with such travel; home care; personal care home services; long term care; oral health care, including dental care and dentures; vision and hearing care and personal aids to help mitigate sight and hearing loss; issues that impact mobility, independence, and healthy and productive living, and much more.

In addition, the Coalition has expressed concern with the rising inability of older persons to maintain their own homes due to the escalating costs of home maintenance and such needed utilities as heat, light, and water, and of course, taxes; all giving rise to an invisible and very disturbing rise in seniors' homelessness. And not to be forgotten is financial security, whether that comes from Old Age Security, Canada Pension, Guaranteed Income Supplement, private pension, public sector pension, all forms of income assistance, or any other income source. One thing that is known is that people living on fixed incomes are seeing their purchasing power dwindle and as costs go higher on such commodities as fuel, food production, and transportation delivery costs, those with

no hope of any increases will sink further into poverty or will have severely diminished ability to purchase and live comfortably as they age.

If all of the above is not strong argument for a powerful and united voice, there is the looming fear of what the impact will be on electricity rates when the ominous monster of "Muskrat Falls" is in production. This is a conversation that the Coalition intends to take public in the next while as we cannot stay silent for long. Older folks, other vulnerable folks, and indeed all citizens of our Province are worried. Some folks are selling their homes and moving away, others are looking at installing devices that promise a reduction in electricity consumption, and still others (probably most of us) are confused and give the matter only passing thought, because if we do not speak of it, maybe it will not happen. Last I looked, miracles are few and far between, if at all, so best we be prepared and speak out now so that those in positions of authority know our concerns and there is still time for action.

We are planning to sponsor a Town Hall meeting on this issue. We expect to present a panel of experts with opportunities for the audience to ask questions, to share concerns and fears, and to offer forth stories of what the impact will likely be or has been for them. This will be a powerful meeting and high media coverage can be expected. The logistics will be communicated when the plans are finalized, mostly likely in the Fall.

Here is a brief account of the other areas of focus for the Coalition over the past little while:

The Coalition took a leading and proactive approach with the Provincial Government not to penalize older citizens who might be recipients of GIS back payments through no fault of their own. This involved a number of meetings, including a request that any folks who might be so impacted not be set up in an overpayment situation for offsetting provincial benefits they might have received due to a bureaucratic clerical error. While we understand the impact to have been very small in our province, we did succeed in having no repayment accounts established.

The Coalition was also actively involved in a number of meetings last year with the Minister and staff of the Department of Children, Seniors, and Social Development to provide input to the Act Respecting the Seniors Advocate and the Regulations, as well as

working with the Public Service Commission to articulate the requirements and qualifications for the person who would fill this position. Since her appointment, we have met with Dr. Suzanne Brake to share a list of systemic concerns impacting seniors in this province. These meetings continue on a regular basis.

The Coalition was also quite heavily involved in providing feedback on the Personal Home Care Review Consultations and Report, following up to ensure the response of Government to the recommendations is acted upon, and continuing to hold accountability to the bureaucrats who are charged with actioning the recommendations. Meetings on this issue are continuing. The Coalition is also participating in the Healthy Living Assessments Working Group and will engage on the development of the Home First Initiative, both of which are significant segments leading to a full system of community care for older persons.

The Coalition continues to hold meetings with our NL federal members of Parliament. These meetings are beneficial to both the MPs and the Coalition as the MPs have a forum to hear first-hand the pressing issues affecting seniors in Newfoundland and Labrador and the Coalition has the opportunity to hear responses and positions on these issues as well as the opportunity to inform the politicians on the impact of these issues and identify new emerging issues. These meetings will continue into the future.

The federal Bill C-27 has consumed a lot of time for the Coalition this past year. The Coalition has been very supportive of the National Federal Retirees Association

and the Canadian Coalition for Retirement Security in their fight against the action that was proposed by Bill C-27, submitting our own letter to the NL Members of Parliament, the Minister of Finance and the Prime Minister. We have been responded to, but so far, the Bill is still on the Government's agenda, even though there may be little chance of proclamation due to a plethora of issues, including conflict of interest by the Minister of Finance.

Last, but not least, the Coalition has continued to lobby for a universal Pharmacare Program, a National Seniors Strategy, and the establishment of a dedicated Ministry for Seniors.

While the individual organizations participating in the Coalition continue to maintain the integrity of their own purpose, this collaborative approach to speaking out and speaking up on the issues of collective concern to all older persons, whether retired or not, whether receiving a pension or not, whether living at home or elsewhere, represents real power when it comes to public awareness and influence on social policy. The collective influence of the Coalition will be used wisely, with broad consensus, and will not be used for partisan purposes. The member organizations see the benefit of using their individual expertise to work together for positive change and are very optimistic that this collaboration will prove beneficial for all citizens. The intent is to create change for the better and to do that the Coalition organizations are confirming they will work together and with Government, where appropriate, to ensure that the issues impacting all seniors are heard and addressed.

CPPIB (Canada Pension Plan Investment Board)

Invests for Canadians

On March 14, 2018, I had the privilege in my role as President of the NL Chapter of CARP to attend the luncheon meeting of the St. John's Board of Trade, where Mark Machin, President and CEO of the CPPIB, was the guest speaker. I attended this event, accompanied by Neil Hamilton and Mike Siscoe from the CARP NL Executive Committee and Doreen Noseworthy, President of the Retired Teachers' Association of Newfoundland and Labrador, with a huge thank you to the CPPIB for the complimentary tickets. Our team was privileged to share the head table with Mark, Anthony Germaine, and the President of the St. John's Board of Trade, Andrea Stack.

Mark Machin was an incredibly engaging speaker with an outstanding resume. He joined CPPIB in 2012, as CPPIB's first President for Asia, becoming Head of International in 2013, where he was responsible for CPPIB's international investment activities, before becoming President and CEO in June 2016. Prior to joining CPPIB, Mark had a 20-year career at Goldman Sachs, where he ran the Investment Banking Division in Asia for six years.

In his speech and during the fireside chat facilitated by Anthony Germaine of the CBC, Mark undertook to debunk some of the myths surrounding the CPP. He explained that the CPPIB exists to manage the CPP Fund and today invests over \$300 billion in funds across 45 countries in public and private equity. Mark further explained that the CPP Fund is one of the 10 largest retirement funds in the world, yet Canadians' knowledge of the Fund and its security processes is low, leading to unnecessary worry about the future of the Fund and their own future. In fact, 66% of Canadians do not have confidence that the CPP will be there for them when they retire. The performance of the Fund, however, tells a much different story.

In the mid-1990s, concern arose about the long-term viability of the CPP, as CPP assets had started to be depleted by 1993. In response, Canada's provincial and federal governments agreed to create bold reforms to ensure the CPP would be there into the future. Contribution rates were increased and the CPPIB was created to invest funds not currently needed to pay benefits.

In fiscal year 2017, the Fund realized a net return of 11.8% after all costs were reconciled. The CPPIB added \$33.5 billion in net income after costs and received \$4.3 billion in net contributions. By the end of the fiscal year, the CPP Fund grew to \$316.7 billion, an increase of \$37.8 billion over the previous year and \$20.1 billion over the last 10 years. There is currently \$337 billion in the CPP Fund. The Chief Actuary noted, in his most recent three-year review of the CPP Fund, that the investment income from 2013-2015 was 248% higher than anticipated due to its strong investment performance. The Chief Actuary has also projected that the CPP Fund will reach approximately \$370 billion by the end of 2020.

So, what are some of the global investments? The CPP Fund is invested in 45 countries in which there are private holdings and there are 227 global investment partners, with 182 being the total number of global transactions in 2017. So, here we are:

- GlobalLogic, California (digital product development);
- Advanced Disposal, Florida (solid waste);
- Canadian Office Portfolio (office properties in Toronto and Calgary).

With 20 million contributors and beneficiaries, the good news for the CPP Fund is that, with professional and diversified investment and sound oversight, the Fund has a projection of 75+ years of sustainability.

Proposed Wording of Changes to RTANL Constitution/By-laws re Election of Office, Vacancy and Subsequent Terms of Office

- No article currently covering term of President or Immediate Past President.
- Recommendations for inclusion, enhancement or replacement:

BY-LAWS

Article VII: DUTIES OF OFFICERS

A. Office of President (*Recommendation for inclusion*)

- 1) The Term of Office shall be for a two-year period from October/BGM in the year the President was elected to the October/BGM of the second year following.
- 2) The Office shall not be held for more than two successive terms by the same person. A portion of a term shall be considered a full term.
- 3) Upon election to office, the following oath shall be sworn to or affirmed: "Upon my honour, I declare that I will faithfully and to the best of my ability, carry out the duties prescribed for the position of President of the Retired Teachers' Association of Newfoundland and Labrador; that I will defend, and act within, its Constitution and By-Laws, upholding its policies with integrity; that I will not knowingly seek personal gain from this office".
- 4) Upon election and swearing in of a new President, the Immediate Past President, provided s/he so desires, shall serve as an Ex Officio Executive Member for the first year of the new President's term of office.

Article III: G. (*Recommendation for inclusion*)

Ten (10) Executive members shall be elected biennially, and the four (4) who have the greatest number of votes shall, with the President, Vice-President, Secretary, Treasurer and a person holding office under By-Law VII A (4), where applicable, form the Provincial Executive and that the total Executive Membership shall not exceed nine (9). The remaining elected members shall be classified as Alternate Members.

CONSTITUTION

Article VIII: A. (*Recommendation for enhancement*) The Provincial Executive shall consist of President, Vice-President, Immediate Past President [By Law Article VII: A. (4)], Secretary, Treasurer and four (4) or five (5) Members-at-Large [(By-Law Article VII: A.)], provided there are not more than three (3) Members of the Executive from any one (1) Division and that the total Executive membership shall not exceed nine (9).

Article VIII: D. (*Recommendation for enhancement*) Any vacancy occurring among the members of Executive of the Association, through any cause, shall be filled by the Executive from the Alternate Members provided under By-Laws Article III. (G), in order of the number of votes received, provided that there are not more than three (3) Members of Executive from any one (1) Division.

Article X: Meetings

A. Provincial Executive Meetings (*Recommendation for replacement/enhancement*)

1. The Provincial Executive shall have two (2) meetings annually. [Also reflects necessary change to By-Law Article 2. A. 1. – Two (2) years to replace three (3) years]
2. Provincial Executive Meetings may be held electronically by teleconference, Skype, FaceTime, Video Messenger...when deemed necessary.

In keeping with Constitution Article V: A. Membership Fees – Be it resolved: That membership fees of RTANL be increased from seventy-five cents (\$0.75) per pay period, (totalling \$18.00 per year) to one dollar and twenty-five cents (\$1.25) per pay period, (for a total of \$24.00 per year).

Rationale: RTANL is the only voice for retired teachers in NL; therefore, its importance cannot be underestimated. The last fee increase was in 2002. We are still trying to provide the same services to our members in 2018 with the same dollar value that existed almost 16 years ago. Operating an association, with the geographical outreach and challenges that Newfoundland and Labrador have, is next to impossible, based on our current income. If we are to remain viable and move our members forward in procuring the kind of standards of living they deserve as they age and retaining the kinds of benefits they have accrued over the years, we need to be able to operate in today's world. We recognize that the same thing applies to the Divisions within RTANL and that they, too, have been trying to do the impossible. As many of you will know, the fees we receive from our members are split 50/50 between the Provincial body and its seven (7) Divisions, based on membership within each division. We realize that Divisions have had to cut back on the kinds of events they were offering their members because of escalating costs within the business community.

We anticipate that the increase we have proposed should hold us in good stead well into the future, hopefully, for the next 10 - 15 years.


