## **President's Message**

I thought that after our BGM we, the Executive, would get a little break. But alas it was not to be. Our first new Executive meeting took place on October 6 in Corner Brook. This was an initiation for the newest members.

The day after the BGM ended in Corner Brook it was off to present at an NLTA pre-retirement seminar in Grand Falls-Windsor. This was the start of a series of pre-retirement seminars that saw the Executive participate in sessions on October 14 in Corner Brook, October 28, November 10 and November 25 in St. John's, and December 9 by a virtual setting.

On the fifth day after BGM our worst fears were realized with a memo from two of our members informing us that they and the spouse of one had all tested positive for COVID-19. The Table Officers immediately contacted every participant at the BGM. Within two hours we had contacted everyone who may have come into contact with the virus. Thankfully, the virus did not infect too many of our members, though any exposure from our event was worrisome.

As President, I brought greetings to the Newfoundland and Labrador Public Sector Pensioners' Association AGM on October 12, 2022. We collaboratively serve on the Coalition of Seniors, Pensioners and Retirees and as such, advocate for our members in a coordinated manner.

On October 18-20, Vice President Joe Lafitte and I represented the RTANL at the Eastern Canada Retired Teachers' Organization (ECRTO) conference in Montreal. This group will reconvene in October 2024 in New Brunswick.

On November 1, the Canadian Association of Retired Teachers (ACER-CART) met on Zoom. Every province and territory had at least one representative present. Martin Higgs, the President of ACER-CART welcomed all. He complimented QPARSE on the conference they hosted in October. He reminded the Zoom attendees that today would be an information seeking meeting. The strategic elements would be refined and collated during an Executive meeting in January. Over the course of the hour and half meeting each provincial organization outlined its priorities

for ACER-CART and how they would be implemented at the local level.

November 7 and 8 saw us meet as an Executive for our first full scale Provincial Executive meeting. This meeting took place in Port Union.



While in the Bonavista area we had an opportunity to meet face-to-face at a luncheon with the members of the Bonavista Division. Despite being one of our smaller divisions, they are quite active and can serve as an example to our larger divisions. The types of activities they are able to accomplish with limited numbers and limited funding is truly amazing. They are inspiring to see in action. It was at this meeting that we reviewed and started to implement the motions passed at BGM 2022. During these meetings the Committee structure of the RTANL was reviewed and each member was assigned a committee to chair.

Issues highlighted by our members continue to be a source of concern for us. Since our last newsletter we have received complaints about the response time in having insurance claims paid by Johnson Inc. and we have been made aware of an inconsistency in our travel coverage through Johnson Inc. We have also been informed that there are some discriminatory issues with the substitute list, especially as it pertains to retired persons on the list. These concerns were discussed at our executive meeting and were addressed with the Department of Education and Johnson Inc. respectively.

We look forward to meeting with all the Division Presidents during our next Executive Meeting which is scheduled for early June 2023 in St. John's.

As we head into the winter months, avail of the health measures available to us, take time to enjoy the quieter days of winter, and we will emerge into a brighter more vibrant life in the spring.

## **MUN 100th Anniversary Celebrations**

Members of the Faculty of Education, both past and present, gathered on September 16 and 17, 2022 for *A Time!* And what a time it was!

The event, officially known as the 100th Anniversary of the Faculty of Education, was a two-day event spread over two locations. It started on the evening of the 16th with an opening session of formal greetings and Land Acknowledgment by Mr. Rob Kelly, Conference Chair, Dr. Gerald Galway, Interim Dean, Faculty of Education, Mr. Tony Stack, CEO/Director of Education, Newfoundland and Labrador English School District, and Dr. Jennifer Lokash, Interim Associate Vice President (Academic), Memorial University. There then followed a presentation by Ms. Jodie Lane, Director of Education, Nunatsiavut Government. Her presentation was titled "Education in Nunatsiavut Past, Present and Future". She spoke of the use of western curriculum and goals imposed on the Inuit. She then introduced and elaborated on the pioneering work of Dr. Beatrice Watts and her initiative to bring the Inuktitut language and the Inuit culture into the schools. Dr. Watts' work led to the development of the Teacher Education Program of Labrador. This program and its successor programs were valued and supported by the Nunatsiavut government.

The Labrador Inuit Society and Culture 2211 course is now being offered across Labrador and is being introduced across the island in the coming school year. At the University level a new Inuit Bachelor of Education (IBED) has been implemented with 10 graduates to date. The work continues with the goal being Inuktitut being the language of instruction in the schools, with appropriate culturally and language relevant resources to

support the program.

Ms. Lane outlined some of the supports available native Labradorian and students how these supports have enhanced the educational experience of students. Ms. Lane has an optimistic and positive attitude toward achievement of the goal of Inuktitut becoming a more vibrant and alive language in the school system.

The evening session started with entertainment by Amy Collyer-Holmes and Daniel Fuchs and ended with entertainment by Arthur O'Brien and Fred Jorgensen of The Navigators.

The second session was a full day session. We were greeted upon arrival by the music of Matthew Rait. Again, Land Acknowledgments and greetings were offered by Rob Kelly, Conference Chair, Dr. Greg O'Leary, Deputy Minister, Department of Education, Mr. Trent Langdon, President, Newfoundland and Labrador Teachers' Association. Mr. Peter Smith, Directeur General par Interim, Conseil scolaire francophone provincial de Terre-Neuve-et-Labrador, and Dr. Gerald Galway, Interim Dean, Faculty of Education.

The second session of day two was a presentation by Dr. Phil Warren, former Minister of Education and Dr. Karen Goodnough, Professor and former Dean, Faculty of Education.

Dr. Warren addressed past teacher education and enthralled us with an overview of the Faculty of Education from its inception as a Normal School in 1921 to the institution it is at Memorial today. Formal teacher education in Newfoundland and Labrador began with the Normal School which operated from 1921 to 1932 with a budget of \$1 million. It was replaced by the Men's University College which operated from 1934 to 1949 with approximately 1,000 students during that time. In 1949, Memorial University of Newfoundland came into existence and thus began the formal degree granting faculty. As an illustration of the success of MUN as a teacher training institution, Dr. Warren informed the group that out of the 2,400 teachers in the province in 1949, only 54 had degrees. By 1985, only degree holding teachers were being hired. By 2020, 100% of teachers in Newfoundland and Labrador held degrees – 16% of those had a Grade 5 designation, 24% had a Grade 6 designation, while 60% had a Seventh Grade. Between 1950 and 2022 Memorial awarded 28,000 Bachelor's Degrees in Education (B.Ed.). A Master's Degree Program was introduced in 1966 and since that time, 6,000 Master's Degrees have been awarded. Dr. Warren spoke of the Distance Education teaching component pioneered out of necessity in Newfoundland and Labrador. We, in fact, have led the country with this method of teaching, therefore teaching during the pandemic did not require the development of a remote teaching protocol because we already had one in action. Dr. Warren ended his part of the presentation with the well-founded assertion that Newfoundland and Labrador's public school system has one of, if not, the most highly credentialed teaching staff in the country.

Dr. Karen Goodnough addressed current and future teacher education pedagogy. She spoke of the teacher education system as having been constructivist and content-based in the past as opposed to today's competency-based and research-based models. She challenged the assembled group to consider what would be the three main ideas or concepts that would guide them in the design of a teacher education program. The question generated a myriad of identified components. She then addressed the standards in teacher education, how they can support teacher learning, the affordances of standards and the harms of standards. Next, she had us consider if the strengths of working with professional standards can be gained in other ways. Dr. Goodnough indicated that accountability has been used as a policy tool to improve the quality of teacher education in this province and will do so for some time.

At the conclusion of the joint presentation Mr. Trent Langdon, President, Newfoundland and Labrador Teachers' Association, Ms. Sharon Penney, President, Retired Teachers' Association of Newfoundland and Labrador, Mr. Tony Stack, CEO/Director of Education, Newfoundland and Labrador English School District, Dr. Greg O'Leary, Deputy Minister, Department of Education, Mr. Rod Jeddore, General Manager, Miapukek Mi'Kamawey Mawi'omi, and Taylor Stocks, PhD Candidate, responded to the presentation. Each panel member addressed their expectations of the Faculty as it moves forward as the pre-eminent teacher training institution in the province.

During the break music was provided by St. Bonaventure College Elementary Choir. The conference attendees then broke into smaller groups for a series of concurrent sessions. During the luncheon there was a formal presentation of artwork to the Faculty of Education. "Education is a Continuum", a piece by art scraper Don Short, was presented by the RTANL.

Ms. Lisa Brown, Vice President, Advancement and External Relations, Memorial University, spoke briefly, congratulating the committee responsible for the celebration and this successful event. She recognized the Faculty of Education for their long, high calibre service to the students of the Faculty and by extension, the students of the province.

The next session was titled "An Abiding Influence: Snapshots of Teachers, Teacher Education and Culture in Newfoundland and Labrador". This was co-presented by Dr. Ursula Kelly, Professor, Faculty of Education and Dr. Clar Doyle, Professor Emeritus, Faculty of Education. Theirs was a multi-media presentation highlighting the impact of teachers and teacher educators on the socio-cultural and historical fabric of 20th Century Newfoundland and Labrador. This was accomplished through a selection of stories, photos and songs from around the province.

After a musical presentation by the Mcdonald Drive Junior High School String Ensemble, the concurrent sessions resumed. The final evening session began with music by Shalloway Youth Choir. Before the banquet, Mr. Rob Kelly, Conference Chair, spoke of the Inaugural Legacy of Leadership Awards. This initiative is designed to recognize long-term dedication to Leadership in Education in Newfoundland and Labrador. Dr. Gerald Galway presented the Legacy of Leadership Award Post Secondary to Dr. Sylvia Moore, and the Legacy of Leadership Award for K-12 to Dr. Clar Doyle, both of whom are very deserving candidates.

Dr. Vianne Timmons, President and Vice Chancellor of Memorial University then spoke to the conference attendees. Dr. Timmons outlined her path to Memorial and gave us an insight into her plans for MUN under her tutelage. She gave us a peek into her private life, telling a short story about her granddaughter to illustrate the changing society into which MUN will continue to educate competent teachers.

It was then Dr. Timmons' honour to introduce the keynote speaker for the evening – Mr. Roger Grimes, former Premier of Newfoundland and Labrador and former President of the NLTA. Mr. Grimes spoke of the changes that have occurred from the days of the denominational system through to the integrated system to the non-denominational system to the two Boards of today and projected as to what education would look like under the single system that is yet to come. He is uniquely

qualified to speak to this as he was a student in both the denominational and integrated system, and a teacher during the denominational system. He was the Minister of Education during the transition to the non-denominational system and Premier as the full implementation of the non-denominational system materialized. Mr. Grimes referenced many of the incidents that necessitated the changes in the educational systems of this province. His humorous recollections of the intricacies of the systems made for an enjoyable evening.

The evening ended with entertainment by Peter Halley and Shelley Neville of Spirit of Newfoundland and Labrador.

Mona Rose, Chair of the RTF, and I proudly represented the RTANL at the event. We can attest that it really was quite *A Time!*

### Social Isolation and Loneliness Can Affect Seniors' Health

Do you know that social isolation and loneliness can have a negative health impact that is as serious as cigarette smoking? Are you aware that having social relationships and partaking in activities outside the home can increase your life expectancy?

Social isolation and loneliness are different but related realities. Social isolation is measured by the extent of our social network, and how we have contact with others. Loneliness, however, is a more personal experience, an inner sense of being emotionally isolated from others. Loneliness is felt most profoundly when there is a large gap between the level of connection we desire and the connections we actually enjoy. Interestingly, a person can be lonely but not isolated, or isolated but not lonely.

Social isolation and loneliness are common among seniors in Canada. According to data from a recent survey of older Canadians living in the community, 16% of those surveyed reported that they felt isolated from others often or some of the time, having no one to listen to them or having no one from whom to get advice at the time of a crisis. This is very concerning. Overall, 17% described the feeling of being excluded often or some of the time.

There are many risk factors that can increase the likelihood of social isolation in seniors. These include being a caregiver, living alone or living in rural and remote areas, living in poverty, living with mental health issues (including Alzheimer's disease and other dementias), and living with chronic health conditions or disabilities. The recent pandemic and continuing concerns related to socializing with others are also playing a part in keeping seniors isolated.

A recent medical study looked at the relationship between social relationships and survival. It examined 148 studies on this topic, with over 300,000 participants, and identified a 50% increased likelihood of survival for people with stronger social relationships, independent of their age or gender. This study also showed that the negative impact of social isolation and loneliness could be similar to smoking 15 cigarettes a day, shaving eight years off the average life expectancy. These findings, and those of other medical studies, also showed that social isolation and loneliness can be associated with higher rates of heart disease and stroke.

So, now that you are aware that social isolation and loneliness can have a negative impact on your health, what can you do about it? Depending on where you live, it might not be easy to find social connections or access activities that would allow social interaction. But, in every community there must be something that can get you out and involved. Of course, the easiest social network to access for many of you would be your own RTANL Division. Join in their activities, go to their meetings, attend their socials; become an active member. If that is not an option, look around your area to see how you might get involved. Is there a theatre where you can attend a movie or a performance? Is there an arena where you can go for a skate or curl, trails where you can stroll at your own pace, a pool where you can swim or do exercise classes, or a gym where you can work out or do yoga? Is there a seniors' group that gets together for games or activities? Is there a church group, a choir, a Lion's Club, or an auxiliary (Legion, Health Care, etc.) that you can join? Are there places in your community where you can volunteer (food bank, a seniors' home, hospital)? Find something you might like to try and do it. You don't have to dive in headfirst, just dip your toe in to feel it out. If someone asks you to do something, like go for a walk or come by for a cup of tea, do that. Invite someone to do something with you. Engaging in gentle physical activity or more stringent activity, depending on your ability, will do your body and mind a world of good. Taking part in group activities, whether it is with one other person or 20 other people, will help you build a social network. If nothing is available, then maybe you could create your own group or activity. There may be others out there who are looking for something to keep them busy as well.

Whether you get involved in one activity or many, your life will be enriched by getting out of your home and taking part in activities with other people. Just having things on your calendar, other than appointments, to look forward to will brighten your days and have a positive impact on you, and your health.

## **Political Action - The Coalition**

The Health and Hope 2025 Campaign, a project of the Canadian Health Coalition (CHC), met for their inaugural web seminar on September 14, 2022. This session was hosted by Pauline Worsfold, Chair, Canadian Health Coalition and Anna Legace-Dawson. There were approximately 150 participants representing all parts of the country and different organizations whose focus is seniors, families, health, and government policy.

The webinar featured Jagmeet Singh, leader of the federal New Democratic Party. Mr. Singh fielded questions from participants across the country.

Mr. Singh addressed the origins of the Confidence and Supply Agreement (CASA). He characterized it as a deal to support the Liberal government if a confidence vote is called. In return, the NDP insisted on a written agreement with defined details and deadlines. Mr. Singh concedes that it has not been an easy process, but it does have its merits and provides the NDP with a forum to move ahead some of its initiatives.

Ms. Legace questioned why this announcement on dental care, while probably the most significant expansion of healthcare in generations, was not truly universal?

Mr. Singh reiterated that he and his party firmly believe in universality of dental care. This initiative as it exists is a first step, with further expansion to cover other groups of Canadians coming in the next year. This first step covers those who had no coverage at all.

When the problem of access to primary care physicians was broached, Mr. Singh voiced that the first priority was to protect the coverage provided by our existing Universal Health Care Plan. He indicated that the NDP was unable to get the federal government to increase transfer payments to the provincial governments. He further spoke to the proposed privatization of some health care procedures. Tommy Douglas, right from the start of the Universal Health Care program warned about the need to protect the system. Douglas specifically foresaw privatization as a danger to the survival of universality. The NDP agree than any new monies distributed to the provinces for health care needs to be accounted for. It needs to be used for specific care packages and not just added to general revenue.

While discussing Universal Pharmacare, Mr. Singh referenced the Hoskins Report. This report illustrates a clear path towards the goal. The NDP see the proposed Universal Pharmacare as being modelled on the existing Medical Care Plan. It has been successfully used in other countries. The key points discussed were the development of a national formulary and a bulk purchasing agreement. These measures will streamline and reduce the cost of medications for Canadians. Embracing these two measures should not be seen as an interference in the province's role but should be viewed as a collaboration for the negotiations and purchase of products.

In closing, Mr. Singh insisted that the NDP would enforce the Canada Health Act. They would recognize and address forces that would erode Medicare. He acknowledged that there is frustration for those working within the system and with those trying to access it. He believes we need to channel that frustration towards a solution, not just bandwagon promises.

Mr. Singh accepted an invitation to conduct a webinar with the CHC again.

During the Coalition meeting of August 17, 2022, the Chair, Sharron Callahan, extended a formal welcome to Susan Walsh, the Seniors' Advocate and Tanya Billard. She then facilitated a round table introduction where each representative gave a brief synopsis of their member organization.

Susan Walsh informed the group that she came into her current position via a social work position. She has a history with mental health programming at the Waterford Hospital. She has experience with policy analysis and program development and has held a variety of management positions.

Tanya Billard also comes to her current position through Social Work. She began her career with Child Protection and since 2019 has been with the Seniors' Advocate office.

Ms. Walsh outlined her plans for the office of the Seniors' Advocate and spoke of strategies going forward. She indicated that she is looking forward to hearing from seniors' groups, individual seniors, caregivers, Indigenous seniors, 50+ groups and other like-minded groups as she fulfills her mandate. The plan is to conduct both in-person and virtual sessions as she seeks consensus on the issues that affect seniors. The hope is that the recommendations from the engagement sessions will be publicly available this time next year. She shared that from her interactions with seniors and caregivers she has identified the following as priorities as far as seniors are concerned: housing needs; rising cost of living; review of the transition of the health system; homelessness; and dental, vision and hearing problems. She made a commitment to review the recommendations and associated actions regarding ageing in place. In addition, she plans to address 65+ workers in relation to paying into pensions, CPP, and health plans as it relates to human rights.

Ms. Walsh ended her presentation by complimenting the Coalition on their advocacy work. She then asked for input from the groups present.

Sharron Callahan informed the Advocate that the Coalition believes the formation of a national seniors' strategy is of the utmost importance. As seniors, we are also concerned about Pharmacare, more particularly the delay in the implementation of the program. The mandate letters to the Minister of Health seem to water down the universality component. We are pleased to note that a pilot study will be conducted on PEI.

We need a national focus and direction on healthcare in general, with a specific orientation to dental care and overall oral care.

The Coalition agrees with ageing in place, but we are not clear about the money for this venture. We are unsure how the money is paid out, or even how to access such monies.

Financial security remains our priority; furthermore, we believe changes need to be made to protect pension plans in cases of companies going bankrupt and we are further concerned about changes to the RIF rules.

Concern was raised that nursing home standards are not being adhered to and the system of inspections is not good. An analysis of the website would indicate that the reporting is neither good nor complete. It leads us to believe inspections are not being done. Sharron indicated that the *Building Accessibilities Act* is under review and there are simple changes that could be done cheaply at the time of construction that would make homes accessible far into the future. For example, the enlargement of doorways to 36 inches instead of the current 32 inches or the installation of levered doorknobs rather than the standard round ones would make a huge impact on seniors' lives later in life. Ms. Walsh indicated that this review has been completed.

It was relayed that compliance packaging (blister packaging), while a good method of helping seniors keep their medications straight and is an aide to ensure that meds are taken on time and in the correct dosages, is an expensive way to get your meds. Compliance packages are only available in 28-day supplies, yet prescriptions are written for one month. This necessitates that seniors using compliance packaging need one or two extra prescriptions per year at an extra cost. The cost is dependent upon the number of prescriptions a senior has.

One group has found that compliance packaging is only available in one-month supplies, not the normal 90-day supply that customers can get if the drugs are not blister packed. This is ensuring that seniors using this type of packaging are paying three times the amount for a three-month supply. In small, isolated communities drugs are often dispensed in one month supplies due to lack of competition.

Ms. Walsh was informed that eyeglasses purchased across the island are a lot more expensive than those purchased in St. John's because of lack of competition.

The Advocate was reprised that access to primary healthcare factors into the overall health of seniors. It was outlined that nurse practitioners are not being used to the full scope of practice. It could be augmented if the rules were amended so that nurse practitioners could be paid under the MCP program.

Furthermore, it has been 17 years since the nursing home regulations have been reviewed. The legislation says they must be reviewed every five years.

The idea was expressed that there is need for the Auditor General to go inside the health care system and do a complete audit.

All participants agree that labour issues are a major factor in health care right now. There are simply not enough people to do the work.

Susan Walsh expressed a willingness to return for another meeting to hear our input and to give us an update on the consultation process when it is done and recommendations are developed. She exited the meeting.

The group was informed that we had received a reply from Minister Stoodley regarding seniors and their inability to use some of the technology at the blood donor clinic. We also received a reply from the CEO of Eastern Health addressing the issue as well. He indicates that there is staff on hand to help anyone who needs assistance.

The process of getting rapid test kits from the Red Cross was reviewed and explained. We reviewed how to apply and how to work through the accounting process afterwards.

The group discussed the Public Engagement Social and Economic Well-being Engagement Plan, formally known as the Poverty Reduction Plan. It is headed by Minister John Abbott and online engagement sessions are taking place now. We hope to meet with Minister Abbott after the engagement sessions to be informed of the information gathered.

Our next actions will be to engage with government on the closure of emergency services and possibly increasing the use of nurse practitioners to their full scope of practice.

The Minister of Seniors has started a public engagement with the federal and provincial and territorial governments. Engagement is an online consultation and Coalition members are encouraged to complete the online survey.

Sharron Callahan, the current Executive Director of the NL Public Sector Pensioners' Association (NLPSPA), updated the Coalition that the NLPSPA is in the process of hiring a new Executive Director. When that process is complete and training has taken place, Sharron will leave her current executive position. This in turn will mean a change in chair of the Coalition.

On September 28, the Coalition met with Minister Tom Osborne and his staff – Deena Waddleton, Annette Bridgeman, and Susan Elliot. Ann Marie Cleary chaired the meeting and informed the Minister that the Coalition of Seniors, Retirees and Pensioners request that the government establish a National Seniors' Strategy. She commented that our government has not

made a commitment on this strategy, despite it having national implications. She sought a commitment from the Minister to support this initiative.

Minister Osborne assured her that the Department of Health would engage at the Federal level through the engagement process. He further spoke of our Seniors' Advocate Office and how the Health Accord has a focus on seniors. He informed the group that other provinces are reviewing what we have done here, hoping to use our experience to inform their planning.

When the topic of Pharmacare, and in particular the Newfoundland and Labrador government's position on such a program was discussed, Minister Osborne indicated that in November of 2021 the Newfoundland and Labrador Department of Health had discussions with other Departments of Health in British Columbia. At that time additional funding was further discussed. Nationally there is a desire for all provinces to be treated equitably as the Pharmacare guidelines are developed. The Coalition sought clarification around the universality of the Pharmacare program. Mr. Osborne indicated that our government fully supports the concept. He stated that 17 years ago the Newfoundland and Labrador Drug Plan was initiated. He now feels that there is more of an appetite for this sort of a program from a federal perspective.

We commented that Canada is the only country with a universal Medicare plan that does not have a universal Pharmacare program. We feel that a well managed universal care program will save money in the long run from a health perspective. When medications are taken on time and in the correct dosages, diseases have a shorter duration and are often less severe. Other countries which already have such a plan can be looked to when formulating a Canadian plan. We can avail of other's expertise. There is no need to reinvent the wheel. Minister Osborne indicated that it is important that any plan be sustainable and that Federal funding extend beyond the initial stages.

The Coalition addressed the Health Accord for Aging at Home. The following points were highlighted:

1) Not everybody needs to see a doctor for everything. Some medical practitioners such as nurse practitioners and pharmacists are not practicing to their full scope of practice. If this were permitted, the demand on physicians would drastically be reduced.

- 2) Blister packaging or compliance packaging is an area of economic inequality for seniors. Blister packaging is available only in 28-day formats, while drugs are usually prescribed for a month. These two do not align and those availing of blister packaging for convenience and compliance reasons are being disadvantaged in that they need an extra prescription to account for the days missed using the 28-day dispensing format. In addition, the blister packaging option is only available in one 28-day supply, not like the 90-day supply that is available for the non-blister packed option. Minister Osborne will speak with the Newfoundland and Labrador Pharmacy Board about this concern.
- 3) Building code standards as a way to ensure that ageing seniors can remain in their homes longer was discussed. Simple changes to the building code for wider doors and hallways, paddle handle doorknobs, and wider light switches, for example, would mean that houses would not need major refits to remain a liveable option longer.
- 4) The Coalition asked for the Government position on vaccines such as the Shingles Vaccine and high dose flu shots. Our concern is with accessibly and affordability. The Minister indicated that some vaccines are not provided universally because of budgetary restrictions and the practicality of implementation of a specific program. He indicated a willingness to review the program policy to see if it can be tweaked for expansion.
- 5) Deena Waddleton gave an update on the status of the Dementia Care Action Plan. She advised the group that the action plan for dementia care is in the draft document stage. It was developed after input from caregivers across the continuum of care. The Dementia Action Council, which is composed of representatives from different fields of expertise, including families and caregivers, will make sure that needs are met and that plans for care are enacted once developed. Two meetings have been completed, with two to three more planned to finalize the Action Plan, after which it will go through the formal approval process. Waddleton reaffirmed that the home first approach is the goal. The Home Dementia Program came into existence in late 2020 and was piloted in Central Health with two nurse practitioners and one physician to provide care at home for severe dementia

- patients. It is scheduled to expand to Western this year. Part of the overall plan is to expand the capacity of care homes to meet the needs of patients with needs that cannot be addressed adequately in the home setting. Currently, the Department of Health has three active Requests for Proposals (RFP). The first is for how to provide dementia care in personal care homes. The second is how to provide dementia care in a day care setting. The third is how to provide restorative and low-level care, such as recovery from surgery in a supportive environment.
- 6) We questioned the Minister as to when and if our government will establish care standards in long term care homes to ensure that seniors are not disaffected. In response, Minister Osborne assured the Coalition that our experience during COVID was not reflective of the central Canadian situation. We did a good job of protecting seniors living in congregate settings. Annette indicated that the standards are currently under review. Information was sought from a wide group of users, and some changes in the standards were necessary after the information gathering stage, especially since the COVID experience. Ann Marie Cleary requested a copy of the standards and questioned if the Coalition would be given the opportunity to review the long term care standards before the policy is written. Deena indicated that this could happen.

We inquired how the government will address the situation of the low supply of certain drugs. Minister Osborne told Coalition members that low drug supply has not had a significant impact on the drug supply in this province. If hoarding of drugs does not occur, our supply is adequate to meet our needs. Annette indicated that there is a formal process in place to address this situation if it should arise. She informed us that there are regular weekly meetings with other Health Departments and other stakeholders that identify potential supply issues and problem solve around them.

The next topic for discussion was the Federal plan to address oral care. We indicated that the Liberals/NDP have introduced a dental care plan for students that will expand to cover seniors, and eventually to cover all. We asked for clarification as to the Department of Health's plan for dental care. Minister Osborne said the Department would embrace a plan that included seniors, but as of yet he doesn't have any details on what that

plan may look like. He stated that he hopes it would complement the existing Newfoundland and Labrador plan, which is free and universal up to the age of 12.


Next the topic of digital services was addressed. Seniors have informed us that many services that are being offered as digital services only are discriminatory to seniors and those living in rural parts of the province where connectivity is an issue, or where a particular skill set is not available. If a senior does not own a computer or is not able to navigate a site, they are missing out on opportunities. If seniors cannot renew a license or book an appointment because they live in a non-connected zone, their lifestyle will be impacted. Seniors are identifying the proliferation of digital services as a serious concern. Minister Osborne will discuss this with Minister Stoodley.

The Coalition offered to preview any guidelines or legislation that is being proposed with an eye to eliminating any ageism reference. Minister Osborne agreed that it is important to remove ageist language and will be cognizant of it when policies are being drafted.

Next, we questioned the government's commitment to the "Aging at Home" philosophy and its stated intent that it be the first option for seniors. Yet despite this, a lot of development is occurring with long term care homes. Minister Osborne reiterated that "Home First" is the preferred option because it is cheaper to keep a senior at home than it is to have them in care. He did point out that there will always be some need for long term care because of extenuating physical or medical circumstances. Annette Bridgeman indicated that 5,000 people have used the Home First program. The Regional Health Authorities (RHAs) will complete an assessment and arrange client-specific programs. She did state that the Home Support Program needs significant improvements. She also referenced the Home Modification Program available through Newfoundland and Labrador Housing as a place where seniors can get some assistance with home maintenance and renovations to enable them to remain at home longer.

On behalf of the Coalition, Ann Marie Cleary thanked the Minister and his staff for the meeting and their input and offered our support and cooperation in future endeavours.

## **Group Insurance Managers' Report**

Group Insurance Managers met in St. John's on August 21 and 22, 2022 as part of the annual planning process.

A review of our Health claims experience revealed the following five drugs accounted for \$565,796 of claims: Orcevus, Imbrivica, Revlimid, Macenclad, and Calquence. Under our Catastrophic Coverage Section, there were six members who used between \$100,000 and \$200,000 worth of insurance product, 15 members used between \$75,000 and \$100,000, 21 members used between \$50,000 and \$75,000, while 105 members used \$25,000-\$50,000 in coverage.

A closer inspection of the plan usage indicated that 80% of claims to the Health Plan are electronically adjudicated at the point of sale. Claims to the Dental Plan are adjudicated at a rate of 97% at point of sale. It is expected that electronic management of our plan will become the norm. The insurance providers acknowledge that there will never be a 100% electronic usage for adjudication. There will always be claimants who prefer to have a paper copy of bills and submit claims through our non-electronic means.

Kevin Higgins of Manulife introduced the breakdown of the COVID pandemic waves and how it affected the health plan in general. The first wave resulted in deaths and a restriction of resources, priority went to COVID patients and others did not get diagnosis in a timely manner. The second wave is notable because of the backlog of procedures and delayed interventions for other illnesses. There is also the impact of interrupted care for chronic conditions. The third wave is characterized by psychological trauma, mental illness, economic injury and burn out. The fourth wave is identifiable in that people are not staying in their positions beyond retirement age.

A mental health study indicated that 23% of the respondents experienced high levels of anxiety, 51% reported a feeling of loneliness, 16% reported depression, 41% had lost workdays, 62% of the zillennials reported looking for mental health support from employers, one in three reported burn-out and 1/2 of Canadian households had a member diagnosed with a mood disorder.

Susan Jesso reviewed and compared our claims experience during the pandemic with the experience before it. When examining claims paid by diagnosis, mental health claims are increasing, and respiratory distress claims have stabilized at pre-pandemic levels. Cancer claims have decreased slightly. It is surmised that this is probably due to reduced, delayed or non-existent testing. It is expected that this will jump when full testing resumes and/or when patients are diagnosed at a later stage of disease progression. Muscular skeletal claims have also decreased.

The emergence of a new diagnosis – Long COVID – was discussed. The group was informed that there are commonalties emerging in people with Long COVID. The cluster of symptoms associated with Long COVID include brain fog, shortness of breath, debilitating fatigue, neurological impairment, difficulties communicating and depression. Long COVID is responsible for 1.1% of our claims – 52% are women, 72% had no secondary diagnosis, the average age is 48 years, the majority had been hospitalized, and 58% ended up on long-term disability.

Our next meeting is scheduled for December 10, 2022 in St. John's.

The Atlantic Insurance Trustees Conference scheduled for September 25-27 had to be canceled due to hurricane Fiona. This conference will be rescheduled for 2023.

## **RTANL Executive Report to BGM 2022**

Our last BGM, by necessity, was a virtual one. It is great to be able to have this one as a face-to-face event. The BGM is the venue whereby the work of our organization is completed. Our Reunion Committee has planned a wonderful series of activities to help us celebrate our 50th Anniversary.

When the world shifted to virtual meetings, I erroneously assumed that this would mean a big decrease in the number of meetings I would have to attend. I thought that maybe it was fortuitous that I was assuming the role of President at this particular time. Boy was I wrong! I quickly came to realize that Zoom and WebEx made it possible to have even more meetings, because now nobody had to set aside long periods of time for travel and meetings. As a result, meetings were often arranged to deal with one particular issue or with limited agendas. Since I became President in March 2020, I have taken part in 44 meetings. They were equally divided - 22 by virtual means and 22 as traditional meetings. While both have their merits, I feel that a face-to-face meeting is more effective since it gives opportunities for other incidental topics to be covered and permits networking.

In this new digital environment even the correspondence of our organization has changed. By far the majority of our communication has been by email. In fact, I used Canada Post for only five pieces of mail during the last year, all of which were in connection with this BGM. Traditional telephone calls were limited as well. We did use email over 600 times during that same period. In addition, email is the main mode of communication between our Divisions and members. It is vitally important that the RTANL be made aware of changes to your email address to ensure you are kept in the loop of all our events.

Since our last BGM, the Executive has met at various locations in the province. We had intended to hold each of our executive meetings in one of our Divisions. This was not possible, but we did meet in Clarenville and Marystown. During these two meetings we had the opportunity to have lunch with the retired teachers in the area. These interactions were wonderful opportunities for us to share information and gain insights into what our members view as areas of concern. It is from these meetings that we plan our priorities. Having a firsthand knowledge of members' concerns is a great place from which to plan.

A vital part of our organization is the Retired Teachers' Foundation (RTF) for Children's Charities. As we departed our last BGM we did not have a solid plan for

our Foundation as no Division had come forward offering to oversee the work of the Foundation for 2020-22. After the meeting, a group of retirees from the Con-Tri Division offered to act as the Foundation Board of Directors. A delegation of the new Board of Directors travelled to Corner Brook to meet with the outgoing Board. After some growing pains, the Con-Tri group are up and running. The work of the Foundation has continued uninterrupted, and we continue to donate to our worthy charities.

This year saw Memorial University of Newfoundland and Labrador celebrate the 100th Anniversary of the Faculty of Education. They invited the RTANL to be part of the event. We took part in two seminars at The Rooms in May. The first, on the evening of May 4, was a presentation by Dr. Gerald Galway on *The History of Teacher Education in NL*. The second session, on May 5, was a panel discussion on Teaching in Pandemic Times. In addition, I represented our organization at a panel discussion during the Symposium that was held in September. Throughout the year our members have been involved in the Facebook online series Teacher Tales, hosted by Dr. Jan Bulle. Our members regaled the Facebook audiences with their remembrances of years of teaching and the myriad of situations they encountered. Some stories were downright hilarious while others were almost heartbreaking.

In keeping with the theme of celebrating the Faculty of Education, the RTANL commissioned a triptych piece of artwork by Donald Short and presented it to Memorial University of Newfoundland and Labrador during the 100th anniversary celebration symposium on September 16. This piece of artwork will hang permanently in the lobby of the G.A. Hickman Building. The triptych pays homage to our journey as teachers in this province and the role of the Faculty of Education in shaping the education of students in this province.

This year, the RTANL was invited to the Memorial University/NLTA Ceremony of Induction into the Teaching Profession, which was held on June 2, 2022 at Glendenning Golf in St. John's. RTANL Secretary Don White represented us. Our presence at the event was noted by a welcome from the podium by Stefanie Tuff, NLTA Executive Director. It is nice to have our role in the lives of teachers acknowledged right from the start of their careers. After all, they are not only the future of education in this province, they are the future of our organization as well.

As president of the RTANL, I attended both ACER-CART AGMs. Last year's AGM was held as a virtual event in

keeping with health protocols. I represent the RTANL as a Director, while our Vice President, Joe Lafitte, represented us as an observer. This meeting saw representatives of all the retired teachers' associations across Canada meet to discuss areas of mutual concern. We have two members of the executive who sit on the Coalition and between them ensure we have an attendee at all meetings. The Newfoundland and Labrador Public Sector Pensioners Association, of which the Coalition is a component, has expanded and hired an executive assistant, Sharron Callahan. We are bound to benefit from our association with this growing and dynamic organization.

The RTANL needs the support and active participation of all our members if we are to continue to thrive. I am certain that if the registration for this BGM is an indication of our future, we are in good hands going forward.

Even before I heard the familiar swoosh sound, I remembered about the Pre-Kindergarten program and how we were invited to be part of the process. I was contacted by Scott Linehan, Assistant Deputy Minister of Education,

We were finally being recognized for our experience and expertise in the area of education, and especially early education. There have been many times over the last year and half that I have been proud to say I am President of the RTANL. The role has kept me quite busy.

Over the past term of office I have met the Federal Minister of Seniors, Filomena Tassi, all our provincial MPs, both our ministers of Education and Health, and both Seniors Advocates. I even had the chance to attend the Manitoba Retired Teachers' Association Group Insurance Meeting by Zoom in September. There were numerous online surveys that were submitted ranging from equity and diversity surveys to income and seniors' issues.

I have been invited to be a member of the Faculty of Education Selection Committee for the Legacy of Leadership Awards. As a representative of the Retired Teachers' Association, I am a member of the Arts Subcommittee for the 100th Anniversary of the Faculty of Education Celebration.

It was difficult for us to get our minds around this concept. We felt it was better to have a plan in place rather than write a plan as we were in the process of shutting down.

## **Summary Report from RTANL BGM 2022**

The evening session was a group visit to the Observatory, where we had an opportunity to use the largest telescope in Atlantic Canada to view the night sky. Attendees had an amazing look at Saturn with its rings and some were even fortunate to see Jupiter and some of its moons. The staff at the facility gave a brief lesson on the night sky and showed us how to read and use sky maps. It was a fascinating experience. The bus ride to the venue harkened back to our days as teachers going on field trips.

After this function and back at the hotel at 9:30 pm, we had the cutting of our 50th Anniversary celebration cake by the oldest member registered for the BGM, Stella Butt, from Con-Tri Division. Afterwards, delegates enjoyed tea, coffee, fruit and cheese trays, and of course, cake. Beverly and Patricia then held the first of several prize draws.

The second day was a day to conduct the business of the Association. On Wednesday morning the 50th Anniversary and 17th Biennial Celebration Meeting was opened by President Sharon Penney at 9:30 am. It began with an Invocation followed by a Land Acknowledgement read by Vice-President Joseph Lafitte.

Greetings were then received from the following:

- Dr. Scott Linehan, Ph.D., Assistant Deputy Minister, K-12 & Early Learning (GovNL), on behalf of the Honourable Dr. John Haggie, Minister of Education/ Member for Gander, who had another commitment.
- Tracy Payne, NLTA Provincial Executive member and Chair of the Group Insurance Committee, representing NLTA President Trent Langdon who was out of province attending the Canadian Association of Principals (CAP) Conference, brought greetings from the NLTA. She had a plea to delegates to use their voice in advocacy for education.
- **Jim Parsons**, Mayor of Corner Brook, extended welcome and greetings to all in attendance as well as extolling the service and impact teachers have had in this province.
- Tom Kendell, Executive member, read a letter from the Honourable Andrew Furey, Premier of Newfoundland and Labrador, who was unavailable to attend.

As has been our tradition, the names of members who have become deceased since our last BGM were read aloud by the Executive. Executive members in turn read the 256 names. This was followed by a prayer and a moment of silence.

President Sharon then introduced NLTA Administrative Officer Gabe Ryan, who brought greetings on behalf of NLTA Executive Director Stephanie Tuff who had a family emergency and was unable to attend and perform the role of Parliamentarian. Gabe had agreed to fill in for Ms. Tuff and performed the role of Parliamentarian for the BGM Meeting.

After a cursory review of the agenda, it was approved without additions. The Minutes of the BGM were approved as presented. The next item of business was presentation and debate on the motions printed in the BGM package. Some of the motions were dealt with in the morning session, while some were delayed until the afternoon session and resulted as follows:

### **Changes to the Constitution**

#### **ARTICLE VIII: The Provincial Executive**

D. The Provincial Executive proposes the removal of the words: provided that there are not more than three (3) Members of the Provincial Executive from any one (1) Division.

#### **Defeated**

### **New Addition to the Constitution**

### New ARTICLE X: Winding Up or Dissolution of RTANL

If/when the Retired Teachers' Association of Newfoundland and Labrador (RTANL) is unable to form or maintain a Provincial Executive, a motion must be presented and voted upon by delegates at the next RTANL biennial general meeting (BGM) to dissolve the RTANL. If this situation arises during a non-BGM year, the motion to dissolve the RTANL must be presented and voted upon during a **special** meeting of the RTANL **Membership**. A motion to dissolve the RTANL shall require a simple majority approval (50% + 1) **of those in attendance** to be carried.

If, upon dissolution of the RTANL, and after the satisfaction of all debts and liabilities, any funds remain in the RTANL account(s), said funds shall not be paid or distributed among the members of the RTANL, but shall be donated to one or more registered charities whose primary goal is to support and advance the rights and well-being of children. For greater clarity, any such funds must be donated for the purpose of supporting and advancing education and/or

well-being for children (in Newfoundland and Labrador) with disabilities or children who have a mental or physical illness.

**Note:** The words in **bold print** were added at BGM 2022 as a "friendly amendment".

#### Carried.

### **Changes to the By-Laws**

### ARTICLE I: Quorum

B. (Proposed Wording)

The deadline for Registration for any BGM shall be the end of August of the BGM year. This will allow for cancellation of the BGM should a Quorum not be met. Following a cancellation, a second call for a BGM with at least thirty (30) days notice shall be given. A Quorum shall then constitute the number of Active Members present.

This Resolution was voted to be **Tabled** so that the Provincial Executive could take another look at the wording in bold giving extensive consideration as to the method(s) of communication to members. Secretary Don explained that right now our only means of communication are:

- a) Through email and only about 1500 of our over 5000 members have supplied email addresses. Before we went "green" (electronic), ALL members were requested through several Newsletters to provide emails in order to maintain communication channels.
- b) Approximately 100 members requested hard copies of the Newsletter, so this is their communication channel.
- c) Before we went "green" (electronic), ALL members were notified through several Newsletters to periodically check our website www.nlta.ca/rtanl BETWEEN Newsletters for updated information.

#### **ARTICLE III: Election of Provincial Executive**

G. Eight (8) Provincial Executive members shall be elected biennially, namely: President, Vice-President, Secretary, Treasurer, and four (4) Members-At-Large PLUS the Immediate Past President, provided that the total Provincial Executive Membership shall not exceed nine (9).

### Carried.

### **ARTICLE VII: Duties of Officers**

### **Proposed Wording:**

4. Upon the election and swearing in of a new President, the Immediate Past President shall serve as an ex-officio Provincial Executive member (**removing** the phrase "for the first year of the new President's term of office").

#### Carried.

Whereas Gander is the Central location for the Island of Newfoundland; Whereas most of the RTANL members who attend BGM are seniors; Whereas the price of gasoline continues to increase;

BE IT RESOLVED that beginning in 2024 and continuing thereafter, all BGMs be held in Gander.

### Amended to read:

BE IT RESOLVED that beginning in 2024 and continuing thereafter, every **second** BGM shall be held in Gander.

#### Carried.

The morning session continued with the President's Report. The report and its addendum are printed elsewhere in this Newsletter. The Treasurer's Report was presented by Clayton Rice. A copy of this report is also printed in this Newsletter. Great discussions were held on various topics, reports, and motions during the business portion of the meeting.

### Retired Teachers' Foundation (RTF) BGM

After lunch, Mona Rose, chair of the Retired Teachers' Foundation (RTF), conducted the Foundation segment. She brought greetings from the RTF and congratulated the Retired Teachers' Association of Newfoundland and Labrador (RTANL) on their 50th anniversary. She highlighted the mandate of the RTF, which is to help children with financial needs and to honor deceased teachers through the Book of Remembrance. She presented the financial report for the Foundation, announced the recipients of the Foundation donations for 2021 and 2022 and highlighted that since its inception in 1987, the RTF has donated \$461,750 to charities supporting children in Newfoundland and Labrador. Her report is printed elsewhere in this Newsletter. Later in the afternoon she made an in-person donation to the Mazol Shriners.

As there was no new slate offered to run the Foundation for the next two years, the Con-Tri Division Executive agreed to continue running the Foundation for another two years. It is hoped at that time another Division will step forward to continue the work of the Foundation.

#### BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of The Retired Teachers' Association of Newfoundland and Labrador as at July 31, 2022, and the statements of revenues and expenditures, changes in net assets and cash flows for the period then ended is the historical cost basis and reflects cash transactions.

#### 2. PURPOSE OF THE ASSOCIATION

The Retired Teachers' Association of Newfoundland and Labrador (the "association") is an organization of retired teachers in Newfoundland And Labrador. The purpose of the organization is to increase the professional and social contacts of its members, to maintain a liaison with the Newfoundland and Labrador Teachers' Association, to speak for retired teachers on matters that affect them by virtue of the fact that they are retirees in society, to improve the financial status of teachers retired under the Newfoundland and Labrador Teachers' Pension Act, to keep members informed on developments in education and to support public education and encourage members to be concerned about and become involved with social issues.

## **NL Retired Teachers' Foundation Report 2021-22**

Greetings from the Retired Teachers' Foundation. Also, on behalf of the Board I extend congratulations to the Retired Teachers' Association of Newfoundland and Labrador on your 50th Anniversary.

We have all adapted to living in a new kind of world, but the mandates of our Foundation have remained the same:

- 1. To provide assistance to children with special needs by providing financial help to their respective provincial charities.
- 2. To honor the life and work of deceased teachers through the compilation of a Book of Remembrance.

This is my first BGM report as Chairperson and thus far it has been very rewarding. In May 2021 Con-Tri made a decision to take on the responsibility of the Retired Teachers' Foundation since Western Division had completed their mandate. Thus, I was approached about assuming the role from October 2021 and I was honored to accept. On July 20, 2021, I travelled to Corner Brook, along with RTANL President Sharon Penny to meet with the Western RTF Directors. The transition from Western to Con-Tri was a smooth one. Thank you to Geraldine Wall and her Board for continued support when needed, the Con-Tri branch of the RTANL and the current RTF Board of Directors. I am delighted to report that the Foundation had a fantastic year, contributing a total of \$28,000 to children in this province. Since its inception in 1987, the RTF has contributed an amazing total of \$462,250 to children's charities in Newfoundland and Labrador. Generally, the Foundation itself does not raise money. It's only through the donations and support from the RTANL, each of our eight divisions, and all members and friends who donate so generously to our Foundation that those contributions are made possible. Thank you to each of you for your financial support.

Two formal meetings were held this year. The first meeting for the new Board of Directors was on September 20, 2021. Five directors were present and welcomed. The purpose of this first meeting was to give the new Board of Directors opportunity to familiarize themselves with the Foundation's Constitution and goals, its financial standing, the criterion required by recipients to be eligible for funding, past recipients and applicants and donation amounts from previous years. We were excited to hear a report from the treasurer that funds available amounted to \$28,000. It was decided this full amount would be distributed as follows to qualifying applicants:

• Mazol Shriners Transportation Fund	\$7,000
War Amps CHAMPS Program	\$7,000
Camp Douwanna	\$3,500
• Candlelighters	\$3,500
• Rainbow Riders	\$3,500

criteria outlined in the application. In addition, one previous recipient no longer meets the criteria because they had become a Foundation in their own right and the Charities Directorate states Mona Rose presents a donation one Foundation cannot give financial support to another Foundation).

The COVID world imposed unprecedented constraints upon everyone during the past 2.5 years so the normal face-to-face presentation to recipients had to be replaced by mailing.

The second meeting was held on May 13, 2022. Six members were present. The purpose of this meeting was to get a financial update, consider new requests and receive updates on The Book of Remembrance. Treasurer Pauline Bishop reported that donations received by the RTF from each Division up to that point was \$11,870.25. It was expected that more donations would arrive throughout the summer of 2022. Divisions are encouraged to forward donations to the RTF by the end of August each year so they can be distributed during the next distribution period. The Board received some new applications for assistance. These were presented and discussed but neither met the criteria for funding. It was decided that donations for the next distribution period would be as follows: The War Amps and Mazol Shriners will receive 50% of the total funds of the RTF and the remaining 50% will be divided equally among the following charities: Rainbow Riders, Candlelighters, Diabetes Association NL and NL Down Syndrome Society. I met with our Treasurer Pauline before our scheduled meeting on September 15, 2022, who confirmed that our bank balance has again reached

\$28,000. We are pleased to report that we will be able to distribute amounts similar to those of the past year.

The Book of Remembrance to date has six volumes. These have been deposited to The Rooms archives and are available for viewing. Documentation confirming transfer of ownership to The Rooms was received by the RTF. Volume 7 is currently being compiled. A new standardized form for recording information about a loved one has been created by Calvin Young and is available for printing online. We received nine new entries this past year. We continue to encourage all members to submit an information form for deceased colleagues so they can be honored. Calvin has transferred information received to date to the appropriate format and collated each in Volume 7. Entries were then forwarded to Michelle Lamarche at the NLTA for addition to the website. All information regarding The Book of Remembrance can be viewed on the website nlta.ca under the RTANL link.

Ideally, the main body of the RTF Board should change every two years if possible. This change would enable each Division to become more familiar with the Foundation over time. Since no Division came forth to assume this role, the existing Foundation Board members listed below have willingly agree to remain until June 2024.
