

# **President's Message**

Our first order of business after AGM 2023 was to revive the RTANL/NLTA Liaison Committee. The RTANL is represented on this committee by the President and Vice-President. The NLTA is represented by the President, the Executive Director, the staff person assigned to work directly with the RTANL and the NLTA Communications Officer. This committee is scheduled to meet formally once a year. Our first meeting was productive, it ensured that we retained a presence with the NLTA upon the retirement of our long-time contact, Michelle Lamarche. It also provided us with a mechanism to distribute information about the RTANL and its programs directly to teachers considering retirement. We were permitted to add printed materials to the existing Pre-Retirement seminar packages. We availed of this opportunity to offer our voice to issues the NLTA is facing. We as retired persons are in a unique position, we are aware of the educational systems and processes, yet we can speak openly without fear of repercussions.

We, at the invitation of the President of the NLTA, attended all the Pre-Retirement seminars. We took this time to explain the various aspects of our organization and invited new retirees to join us. We encouraged prospective retirees to submit the required forms at the same time as they are completing the other documents required for retirement. We hope that this will increase our numbers. If all documentation is completed at the same time, it is less likely that we will be missed in the process. This year we shared our meeting time with representatives of the NLPSPA (Newfoundland and Labrador Public Sector Pensioners Association).

We will soon complete our two-year term as the Education Alumni Representative on the Legacy of Leadership Awards for the Faculty of Education at Memorial University of Newfoundland and Labrador. We have been involved in both the development of the criteria for the awards and the selection process, along with being present for the presentation of the awards.

Our executive has met with the Presidents of our local Divisions. We usually meet with our Division Presidents every two years. The half-day meeting featured a fully packed agenda. We felt that it was time to speak with our Divisions as new Regionals had been formed, new Division Presidents had been elected, and some changes that were voted upon at BGM 2022 needed to be shared with our members. On the



afternoon of October 20, after our Division Presidents Meeting, we were invited to a meet and greet with the Executive of the NLTA at their offices. This gave us an opportunity to put faces to names, to share our common concerns with the NLTA, to thank them for their support and to offer our support to them.

In June, Vice-President, Joe Lafitte and I attended the ACER/CART Conference in Ottawa. The meeting schedule was jam-packed. At that meeting, I became a member of the Executive of ACER/CART. I am the new East Coast Representative, and in conjunction with this, I chair the Health Committee.

During the last week of August, the Group Insurance Managers hosted the Atlantic Trustee Biennial Meeting. It is a good venue to share ideas and successes. A more complete report is found elsewhere in this newsletter.

The first meeting of The East Coast Retired Teachers' Organization (ECRTO) was held on September 19, and revealed the following as common concerns:

- 1. Pensions and pension erosion due to the rising cost of living.
- 2. Membership recruitment.
- 3. Databases, maintenance and keeping current information.
- 4. Security of data and websites.

At the ACER/CART Health Committee meeting the following were identified areas of which we need to be cognizant:

- 1. Lack of housing for seniors and low-income persons.
- 2. Lack of supports for ageing-in-place.
- 3. Pension amalgamation.

# **Group Insurance Managers' Report**

This past summer, the Group Insurance Managers hosted the Atlantic Conference here in St. John's. The conference had participants from all four Atlantic provinces. At this meeting, we were afforded the opportunity to do a deep dive and compare our Health Plan with those in our sister provinces.

Under our program, the Basic Life option pays out at two times annual salary or pension. In New Brunswick and Nova Scotia, it caps at \$50,000, while in Prince Edward Island, it caps at \$100,000. The same holds true for Basic Accidental Death and Dismemberment.

In Nova Scotia, the benefit for retirees reduces to \$10,000 at age 65, while in Newfoundland and Labrador and Prince Edward Island, it reduces to \$15,000 at age 65. The New Brunswick retiree benefit reduces to \$15,000 at age 70.

Health insurance plans generally reimburse members at 80% of the usual and customary charges. This is consistent across all the provinces. Hospital coverage in Newfoundland and Labrador, Nova Scotia and New Brunswick is 100% for a semi-private room, while Prince Edward Island covers 100% for a private room.

Our plan sees ambulance services reimbursed at 80%. In Prince Edward Island, ambulance services are reimbursed only when it is medically necessary for ambulance transportation, while in Nova Scotia and New Brunswick, ambulance transportation is covered to the nearest hospital only.

Medical prosthetics are covered at 80% reimbursement in Newfoundland and Labrador and New Brunswick. Prince Edward Island has a \$10,000 lifetime limit, while Nova Scotia has no dollar limit. Medical equipment is covered at 80% reimbursement in Newfoundland and Labrador, as well as New Brunswick, but has a lifetime maximum of \$20,000 in Nova Scotia and a lifetime maximum of \$15,000 in Prince Edward Island.

The paramedical services are very different in each province. As such, it is very difficult to make a valid comparison of the programs. All provinces offer this option in their overall Health plan. The Nova Scotia plan does not provide coverage for vision care after the age of 65. Nova Scotia, Prince Edward Island and Newfoundland and Labrador provide one refraction per 24 months, while New Brunswick reimburses its members at 80% to a maximum of \$84.

Out of province/out of country travel is not included in the health plans but is available as an opt- in addition.

Our prescription drug insurance, like in New Brunswick, is an open formulary plan, while Nova Scotia and Prince Edward Island use a managed formulary to regulate their plan costs.

NL, NB and NS offer dental insurance at 80% reimbursement, except for PEI, which doesn't offer dental insurance to those who are retired.

Critical illness is offered as an option. The basic plan has a \$10,000 limit, except for Nova Scotia, which does not have this option at all.

As you can see, our health plan is comparable to that enjoyed by our fellow retired teachers across the region. In some cases, our coverage is better.

# Frailty... Are We at Risk?

The Oxford English Dictionary defines frailty as an aging related syndrome of physiological decline, characterized by marked vulnerability to adverse health outcomes. As members of the aging population are we destined to be frail? Getting older doesn't necessarily mean that we will become frail, but it does increase the odds of us developing conditions that will make us so. There are things that we can do to prevent this from happening to us. This article is meant to create an awareness of the condition and to discuss some ways to help avoid frailty by taking control of our health.

When we are frail, our body does not have the ability to cope with minor illnesses that would normally have a minimal impact if we were healthy. With frailty, minor stressors may trigger more rapid and dramatic deterioration. Older adults who are suffering from frailty are more susceptible to large declines in health from minor illnesses such as the flu or adverse events like falls. They are more likely to be hospitalized, need Long-Term Care, or die.

One of the key contributors to frailty is inactivity. Taking part in physical and mental activities is the best way to stay mobile, strong and healthy. What is good for the body is good for the brain, and while any form of activity is good, things like walking, gardening, dancing, yoga, swimming and other sports will increase our agility. It's never too late to start! Muscle strength can be rebuilt with physical exercise, and activity and exercise can slow, and in some cases reverse frailty. Remember, though, that older adults need seven to nine hours of sleep nightly to allow the body to recharge and repair.

Poor nutrition is another contributor to frailty. Food is medicine! As we age, we need more of certain nutrients, like the protein in fish, eggs, and other sources, to keep our muscles and bones strong. Calcium and Vitamin D also support bone and muscle strength. Getting the proper nutrition can reduce the risk of frailty and help us live well and longer.

Evidence suggests that loneliness and social isolation can accelerate physiological aging and may lead to other health problems such as depression, high blood pressure and dementia. In fact, loneliness has been associated with a 45% increase in the risk of death. Older adults with strong social relationships enjoy a better quality of life and live longer. Joining a club, taking a class, taking part in activities offered at church or that are sponsored by the RTANL Division, or volunteering in our community, can get us out of the house and help us make new friends or reconnect with old ones. Having something on our calendar to look forward to will make all the difference.

One out of every four Canadians over the age of 65 has been prescribed multiple medications. Many seniors have been on the same medications for years; some may no longer be required, while other new medications may be needed. It's a good idea to have our healthcare provider review all of our medications periodically, including prescriptions, over-the-counter drugs, and even vitamins and supplements. Multiple medicines may interact poorly and cause side effects like poor nutrient absorption, confusion, dizziness and falls, which can all lead to frailty. Vaccines can be of help in keeping us healthy and increasing our body's ability to fight off infection. As we age, our body's ability to fight off infection is reduced. Vaccines can greatly improve our ability to resist infectious diseases and avoid illnesses that can cause hospitalization or lead to poorer health. Adults over 65 years of age should get the high dose flu vaccine annually, as well as the shingles and pneumonia vaccines that are needed only once after the age of 50.

How can we tell if we are at risk? People who are frail usually have three or more of the following five symptoms that often occur together. These include unintentional weight loss (10 or more pounds within a year), muscle loss and weakness, a feeling of fatigue, slow walking speed and low levels of physical activity. We should check with our healthcare provider if we notice these signs.

Frailty is not an inevitable part of aging! We can slow down, reverse, or manage the condition if we have the right information and follow procedures that can be prescribed by our healthcare providers.

# **Coalition/Political Action Report**

The following is a recap of activities and meetings held by the Coalition of Pensioners since my last report in the June Newsletter.

A meeting via Zoom was held on May 4, 2023, at 1:30 p.m. The first highlight of the meeting was that the Pension Protection Bill had passed the Senate and would eventually be enacted soon.

Re: Review of Personal Home and Long-Term Care – Minister Osbourne disclosed that the expert panel has been appointed but did not disclose who the person with lived experience was. Sharron Callahan is working with the Seniors' Advocate to make sure we have input as a stakeholder and request information updates.

The government is conducting a Review of Statutory Offices of the House of Assembly which includes the Office of the Seniors' Advocate. The coalition is compiling a submission to the Review Committee stressing the importance of the office and advocating strongly to have the office retained as it is or improved to respond to the needs of seniors. It will also confirm our strong support for the office to be kept as a separate office and not combined or altered in any way.

There has been no information on the Review of the Appointments Commissioner, except to invite submissions and participation via virtual engagement.

We are still requesting meetings with Federal MPs since our request in November 2022 has not received a reply.

It was disclosed that not all Cost-of-Living cheques have been sent out.

Another Zoom meeting was held on June 26, at 9:30 a.m. The chair disclosed that the Cost-of-Living cheques are easier to access. The Grocery Rebate has been introduced by the Federal Government to help alleviate the hardship of the rising cost of groceries. Based on filing income tax returns, on your 2021 taxes, those who receive the GST Rebate will also receive the Grocery Rebate. No application is necessary.

The Personal Care Home and Long-Term Care Homes Review is still being pursued and we are vigorously demanding active status in that process. We are hoping to be included in the engagements when they start up later in the year. The Review of Statutory Offices of the House of Assembly have set their terms of reference, and the Coalition has filed our submission. The website for the Commission is public, at <u>www.rsonl.ca</u> and all submissions can be viewed here under "submissions" once they are posted.

We are still trying to arrange a meeting with Federal MPs and have a meeting tentatively set for August 15 at 1:00 p.m. with MP Joanne Thompson who is now Chair of the Federal Seniors' Caucus. Sharron Callahan is preparing an Issues Paper to guide the discussion. We are also presently seeking a meeting with Minister Paul Pike, the new Minister of Children, Seniors and Social Development, and a similar Issues Paper will be prepared for this meeting.

At our September 6, zoom meeting at 2:00 p.m., it was disclosed that the Personal Care and Long-Term Care Homes Review panel is in place and that Sharron Callahan is a member of the Community Stakeholders Committees. There are 10-12 people on the Committee representing the various groups, like the Seniors' Advocate, Seniors NL, Coalition of Disabilities, and the Coalition of Seniors, Pensioners' and Retirees' Associations. The committee is scheduled to hold three meetings with the Expert Panel.

The Coalition has filed its Coalition Submission, Office of Seniors' Advocate position paper and has not yet received an answer. It is expected that the Commission will be filing its report with the House of Assembly.

On August 9, a meeting was held with MP Darren Fisher and MP Joanne Thompson. A report was sent but I did not receive it.

A Meeting with Minister Paul Pike was scheduled for September 11, 2023, at 2:00 p.m. RTANL President Sharon compiled a discussion paper that outlined the issues being advocated for by our group.

A meeting with Tom Osbourne, Health and Community Services has been deferred and a meeting is pending with Mark Duggan, Director of Issues Management, Minister of Seniors.

An in-person meeting with Honourable Paul Pike, Minister of Children, Seniors and Social Development took place on September 11 with coalition members in attendance. When the meeting convened, Minister Pike was unavailable due to last-minute commitments and in his place representing him were Henry Kielley, Director, and Lori Rose, Assistant Deputy Minister. The prepared Issues Paper was discussed and only some of the questions were addressed. There would be an announcement on the Social and Economic Well-Being Plan (Poverty Reduction) during Well-Being Week (September 17-23). Other issues addressed were: The Adult Protection Act, Elder Abuse, Position of the Seniors' Advocate (under review), Intergenerational Program Guide, Ageism, Promoting Age-Friendly Communities and offering funding, Aging in Place Strategy, building a relationship with the Federal Minister of Seniors', advocating for a National Seniors' Strategy, and seniors' issues with the push by government towards digital servicing. Mr. Kielley assured the group that a further face-to-face meeting would be arranged with the minister and a written response to their concerns would be compiled.

A meeting with MP Joanne Thompson was held on October 10, 2023, at 2:00 p.m. It was discovered on arrival that Ms. Thompson was unavailable and her Constituency Assistant, Heather Matthews, quickly arranged to have us meet via zoom with Colleen Wright, Parliamentary Assistant, at Ms. Thompson's office in Ottawa. There were 11 coalition members in attendance. The topics discussed were those contained in the Issues Paper, submitted earlier to Ms. Thompson and Minister Paul Pike. Congratulations were extended to Honourable Seamus O'Regan on his appointment to the portfolio of Minister of Seniors in Ottawa. All the members around the table introduced themselves and we went through the listed issues and outlined our concerns, topmost of which were a National Seniors' Strategy, Pharmacare and issues with the New Horizons for Seniors Program. All other issues were discussed, and we were assured that future face-to-face discussions would be scheduled with our new Minister of Seniors. We look forward to a fairly busy fall and winter season as we advocate on behalf of our members.

# Teachers' Pension Plan Designation of Beneficiary

Under the former Act, a plan member could only name a beneficiary if they did not have a Principal Beneficiary, a dependent child or another dependent and then only if the named beneficiary was dependent upon the member for financial support. Upon the death of a member with no principal beneficiary, any death benefits would be paid to the plan member's estate, with no option for the benefit to be paid to a named beneficiary. This could potentially have negative financial implications for the member as the member's estate is subject to tax and accountable to creditors. Payments to a designated beneficiary would mitigate these considerations.

Section 7 of the Plan Text now provides that a plan member may designate a beneficiary to receive a benefit payment. A separate communication was mailed to all plan members outlining all necessary actions to be taken in order to designate a beneficiary.

# **Report from the ACER-CART AGM**

The Annual General Meeting of the Association Canadienne des Enseignantes et des Enseignants Retraité - Canadian Association of Retired Teachers (ACER-CART) took place in Ottawa during the first weekend of June. The RTANL was represented by both Vice-President, Joe Lafitte and President, Sharon Penney. All 10 provinces, minus the Yukon, were represented. This past year the Yukon Retired Teachers' Association folded due to the inability to form a new executive.

ACER-CART president Martin Higgs welcomed delegates. A round of self-introductions from the provinces followed the president's welcome. It was interesting and informative to spend time with members of other retired teacher organizations across the country.

This year's pre-AGM meetings business was a morning session on Organization Strategic Planning led by Bob Fitzpatrick of NBSRT.

Participants were self-dispersed to one of four tables with the encouragement to join with delegates from other provinces.

Bob then guided participants through a series of questions to be considered. The first was a series of questions for each member to answer individually. **Q1.** *What would I like to see in a new national organization?* Each table was asked to volunteer some of their answers. **Q2.** *What would this organization look like if it had unlimited funds for staff, communications, etc.?* Again, each table was asked for samples of their responses. This was followed by each table being assigned a topic with several probing questions and as a group, brainstorming suggestions for possible solutions. A recorder for each table presented their answers to the series of questions.

Feedback on the exercise was very positive by the participants and it is an exercise every organization should go through. The end goal is to develop a Strategic Action Plan for the organization. The answers to the questions produced at the four tables will form a basis for ACER-CART Executive as they work to develop ACER-CART's Strategic Plan. We look forward to what they will bring forth.

After this morning session and a lunch break, the business part of the AGM started and the various committees of ACER-CART made formal reports.

#### **Communications Committee:**

This past year, the committee has focused on making improvements and additions to the ACER-CART website, which can be reached at acer-cart.org. A new feature that was added is the Canadian Photo Gallery, a space for members to share their favourite scenic pictures of our beautiful Canadian landscape. The website contains a wealth of information that can be used by groups or persons looking for facts and data on a variety of topics of interest to retirees and seniors. The site is continually being updated and has links to other sites and agencies working to better the cause of retirees and seniors. In addition, the site has links to federal government members, call-toaction documents, health services news, advocacy talking points, and much more. A new section titled "Lifestyles" is coming soon.

#### Pension and Retirement Income Committee:

This ACER-CART Committee surveyed the different Canadian Teacher Pension Plans' Cost-of-living arrangements in February of 2023 and it revealed the following.

All plans use either the Canadian or their Provincial Consumer Price Index in their calculation.

While there are some similarities, each pension plan has a unique way of calculating the amount awarded. Most provinces award increases each January, but two provinces award increases near the middle of the year.

The provincial associations also provided their actual pension increase percentage for both 2022 and 2023.

- 1. The increases awarded range from full cost-ofliving to 0% each year.
- 2. Six provinces award all increases equally to their members.
- 3. Four provinces award different groups of retirees with differing percentages.

From this, we see that the purchasing power of a pension decreases each year when the pension is not indexed to inflation. Even a small loss of indexing reoccurring over many years will lead to a serious loss in the value of a pension. It is clear from the data that most pensioners in Canadian provinces are losing some of their pensions' purchasing power and some are experiencing a severe loss. Their study shows that on average, retired teachers receiving pensions in Canada lost about 2.31% of the

value of their pensions in 2022 and about 3.47% of the value of their pensions in 2023. Some provinces such as Ontario and BC, did much better than average, and some provinces, notably Nova Scotia and Newfoundland and Labrador, did much worse. But the data indicates a worrying future for many retired teachers.

Inflation during the past two years has been higher than in previous years. The average CPI over the past 21 years has been 2.1% per year. Since most of the provincial pension plans provide only a percentage of CPI each year, that means that their pensioners' loss is systemic. Without a change to the system, they will continue to lose purchasing power no matter what the inflation rate is. If inflation is low, their losses will be on a small scale; if inflation is high, their losses will be much more significant.

One cannot expect any improvement to the funding and cost-of-living formula used by teachers' pension plans to come without lobbying and political action. In Canada, retired members on their own, have little opportunity to improve cost-of-living arrangements on pension plans. Only a couple of provinces have retired member representation as a Trustee on Pension Boards. Manitoba recently achieved that status when a private member's bill received unanimous support for government legislating one seat on the Pension Board to appoint a Trustee from the retired teacher group. Most provinces, however, do have advisory committees or other structures with at least some representation from the retired members.

The Pension and Retirement Income Committee outlines that a first step should be for ACER-CART members to use available opportunities to approach active teacher groups within their province to discuss cost-of-living increases. Teacher unions have greater influence with Pension Boards, even where the pension plans are controlled by government. Teacher Unions could also include cost-ofliving improvements in their bargaining objectives or through other pension advocacy mechanisms.

Active teacher groups are a natural ally in the fight to improve cost-of-living benefits as they have the most to gain with them and the most to lose without them. Whatever active teacher groups achieve in pension language improvements for retirees, ultimately will benefit active teachers when they retire themselves. Active teacher groups need to be made aware of the dramatic losses that await them in retirement. This may encourage them to become allies in improving the costof-living arrangements in their own pension plans. There

are also potential allies in other public sector retiree groups within each province. Retired provincial and local government workers and college staff are likely to have similar funding and cost-of-living provisions in their pension plans. Uniting your efforts with large, like-minded groups will increase the effectiveness of any mass advocating efforts.

#### Health Committee:

The Committee agreed with a suggestion from the Political Advocacy Committee that we have a joint meeting regarding the AC priorities of Long-Term Care and Aging in Place. It is also agreed that a National Seniors Strategy, Pharmacare and Dental Care were all identified as priorities.

Group Insurance Plans also received consideration after the committee received a comprehensive overview of plans from Johnson Insurance. The consensus was that the overview could form a template for sharing in the coming year.

Next year, we hope to take an active role in advocating against ageism, the creeping privatization of health services and seniors' poverty.

There are several postings on the ACER-CART website that should be of interest to our members. We are gravely concerned that there was no reference to National Pharmacare in the federal budget. Therefore, the committee recommended that ACER-CART work with members to plan and initiate a campaign for a national Pharmacare program.

#### **Political Action Committee:**

In February, committee members were pleased to learn that PAC proposed a special meeting of the board to "educate" members regarding the issues and discuss strategies to support the priorities within their organizations.

On a somber note, the Retired Teachers' Organization of the Yukon has ceased to exist. This is distressing in that the retired teachers of the Yukon no longer have a voice at the national level.
