Rules of Order

- a) The parliamentary process of the RTANL Biennial General Meeting shall be under the direction of the Parliamentarian.
- b) Members wishing to speak, after recognition by the Chair, shall state their full names.
- c) Speakers, including the mover of a motion, shall be limited to three minutes.
- d) No Member shall speak more than once on a question. The mover of the motion shall have the opportunity to close debate.
- e) Any Member, for information purposes, may request that the motion under discussion be reread, except when another member is speaking.
- f) If a Member, while speaking, is called to order, the member shall cease speaking until the question of order has been decided.
- g) Any Member who continues to exercise unacceptable actions after being called to order, shall be subject to removal for the remainder of the meeting.
- h) An attempt shall be made to answer all questions during the meeting. However, any questions left unanswered will be responded to afterwards and the audience copied accordingly.
- i) Voting shall be by secret ballot.
- j) The Chair shall only be entitled to debate on a subject under discussion after relinquishing the Chair.
- k) When provision is not made in these RULES OF ORDER and the issue is not in conflict with the Constitution, Roberts Rules of Order shall apply. These RULES OF ORDER shall govern the conduct of the Association's meeting after approval by the assembled members at the beginning of the meeting.

9. Resolutions:

RATIONALE:

The Provincial Executive feels that some changes made to The Constitution at BGM 2018 are overly restrictive. Any member of the Provincial Executive should retain the right to resign from office if personal situations warrant such action. Furthermore, the Provincial Executive feels that it is not a viable option to elect an alternate Member-At-Large at a BGM and expect that person to "wait in the wings" so to speak in case there might be a resignation (vacancy) on Provincial Executive. Article VII D (prior to 2018) stated:

Whenever a vacancy occurs on the Provincial Executive, through any cause, the Executive shall name an Active Member of the Association to fill the vacancy until the next BGM, provided that the appointment adheres to Item A of this Article.

Item A:

The Provincial Executive shall consist of: President, Vice-President, Immediate Past President, Secretary, Treasurer, and four (4) Members-At-Large, provided that there are not more than three (3) Members of the Executive from any one (1) Division and that the total Executive Membership shall not exceed nine (9).

Whereas the election of an Alternate Member-At-Large at a BGM now requires that Alternate wait 12 months before holding office while the Immediate Past President completes his/her Term of Office for ONE year;

Whereas such duly elected Alternate might not be interested in such a waiting period;

BE IT RESOLVED that the following changes be made to our **Constitution**:

CURRENT:

ARTICLE VIII: PROVINCIAL EXECUTIVE

- A. The Provincial Executive shall consist of: President, Vice-President, Immediate Past President, [By-Law Article VII: A (4)], Secretary, Treasurer, and four (4) or five (5) Members- at-Large [By-Law: VII: A.], provided that there are not more than three (3) Members of the Executive from any one (1) Division and that the total Executive Membership shall not exceed nine (9).
- B. The Members of the Provincial Executive, with the exception of the Immediate Past President, shall be elected at the Biennial General Meeting (BGM) of the Association for a term of two (2) years.
- C. Election of the Provincial Executive shall be by secret ballot.
- D. Any vacancy occurring among the members of the Provincial Executive of the Association, through any cause, shall be filled by the Provincial Executive from the Alternate Members provided under By-Law Article III (G), in order of the number of votes received, provided that there are not more than three (3) Members of Provincial Executive from any one (1) Division.

PROPOSED: (To read as was prior to BGM 2018)

ARTICLE VIII: PROVINCIAL EXECUTIVE

- A. The Provincial Executive shall consist of: President, Vice-President, Immediate Past President, Secretary, Treasurer, and four (4) Members- at-Large, provided that there are not more than three (3) Members of the Provincial Executive from any one (1) Division and that the total Provincial Executive Membership shall not exceed nine (9).
- B. The Members of the Provincial Executive, with the exception of the Immediate Past President, shall be **elected** at the Biennial General Meeting (BGM) of the Association for a term of two (2) years.
- C. Election of the Provincial Executive shall be by secret ballot.
- D. Whenever a vacancy occurring among the members of the Provincial Executive of the Association, through any cause, the Provincial Executive shall name an Active Member of the Association to fill the vacancy until the next BGM provided that there are not more than three (3) Members of Provincial Executive from any one (1) Division, provided that the appointment adheres to Item A of this Article. (SEE BELOW):

Item A:

The Provincial Executive shall consist of: President, Vice-President, Immediate Past President, Secretary, Treasurer, and four (4) Members-At-Large, provided that there are not more than three (3)

Members of the Executive from any one (1) Division and that the total Executive Membership shall not exceed nine (9).

Carried.

Whereas all Members to the Provincial Executive work for the common goals of the RTANL regardless of their Division

And whereas many Divisions are having difficulty attracting Members to run for office on Provincial Executive

And whereas the "no more than three (3) from any one Division" rule could potentially be a hindrance to obtaining a full Provincial Executive at BGM

The Provincial Executive is recommending the removal of the words:

provided that there are not more than three (3) Members of the Executive from any one (1) Division "from The Constitution, Article VIII A.

Removal of the words: "provided that there are not more than three (3) Members of the Executive from any one (1) Division" was **defeated** by members present at BGM 2022.

By-Law Changes/Additions:

a. Whereas Gander is the Central location for the Island of Newfoundland;

Whereas most of the RTANL members who attend BGM are seniors;

Whereas the price of gasoline continues to increase;

Amended to read:

BE IT RESOLVED that beginning in 2024 and continuing thereafter, every second BGM be held in Gander.

Carried.

b. Whereas the number of RTANL members attending the BGM continues to decrease

BE IT RESOLVED that the current **B-Law Article I: Quorum** be amended:

CURRENT:

That at the Biennial General Meeting and at Special Meetings (either in person or virtually) a majority of the Provincial Executive plus twenty-five (25) Active Members who attend, having been given at least thirty (30) days notice, shall constitute a quorum.

PROPOSED:

A That at the Biennial General Meeting and at Special Meetings (either in person or virtually) thirty (30) Active Members including a majority of the Provincial Executive, having been given at least thirty (30) days notice shall constitute a quorum.

B. That the deadline for Registration for any BGM shall be the end of August of the BGM year. This will allow for cancellation of the BGM should a Quorum not be met. Following a cancellation, a second call for a BGM with at least thirty (30) days notice shall be given. A quorum shall then constitute the number of Active Members present.

It was voted by Members present at BGM 2022 that this Resolution be tabled and re-visited by Provincial Executive.

Article III Election of Provincial Executive:

CURRENT:

G. Ten (10) Provincial Executive members shall be elected biennially, and the four (4) who have the greatest number of votes shall with the President, Vice-President, Secretary, Treasurer and a person holding office under [By-Law VII A 4], where applicable, form the Provincial Executive and that the total Provincial Executive Membership shall not exceed nine (9). The remaining elected members shall be classified as Alternate Members.

PROPOSED: (Dependent upon the outcome of Constitution Article VIII above):

Article III: Election of Provincial Executive:

Omit G as above. ADD a NEW G as follows:

G. Eight (8) Provincial Executive members shall be elected biennially, namely: President, Vice-President, Secretary, Treasurer, and four (4) Members-At-Large PLUS the Immediate Past President, provided that there are not more than three (3) Members of the Provincial Executive from any one (1) Division and that the total Provincial Executive Membership shall not exceed nine (9). Carried.

c. Article VII: Duties of Officers:

CURRENT:

4. Upon the election and swearing in of a new President, the Immediate Past President shall serve as an ex-officio Provincial Executive member for the first year of the new President's term of office.

PROPOSED:

4. Upon the election and swearing in of a new President, the Immediate Past President shall serve as an ex-officio Provincial Executive member. (**omitting** "for the first year of the new President's term of office"). **Carried.**

ARTICLE X (New):

New Article X: WINDING UP OR DISSOLUTION OF RTANL

If/when the Retired Teachers' Association of Newfoundland and Labrador (RTANL) is unable to form or maintain a Provincial Executive, a motion must be presented and voted upon by delegates at the next RTANL biennial general meeting (BGM) to dissolve the RTANL. If this situation arises during a non-BGM year, the motion to dissolve the RTANL must be presented and voted upon during a **special** meeting of the RTANL **Membership**. A motion to dissolve the RTANL shall require a simple majority approval (50% + 1) **of those in attendance** to be carried.

If, upon dissolution of the RTANL, and after the satisfaction of all debts and liabilities, any funds remain in the RTANL account(s), said funds shall not be paid or distributed among the members of the RTANL, but shall be donated to one or more registered charities whose primary goal is to support and advance the rights and well-being of children. For greater clarity, any such funds must be donated for the purpose of supporting and advancing education and/or well-being for children (in Newfoundland and Labrador) with disabilities or children who have a mental or physical illness.

Note: The words in bold print were added at BGM 2022 as a "friendly amendment".

10. President's Report:

(As presented in the BGM Package)

RTANL Executive Report to BGM October 4-6, 2022

President -- Sharon Penney

Our last BGM by, necessity, was a virtual one. It is great to be able to have this one as a face to face event. The BGM is the venue whereby the work of our organization is completed. Our Reunion Committee has planned a wonderful series of activities to help us celebrate our 50th Anniversary.

When the world shifted to virtual meetings I erroneously assumed that this would mean a big decrease in the number of meetings I would have to attend. I thought that maybe it was fortuitous that I was assuming the role of President at this particular time. Boy, was I wrong! I quickly came to realize that Zoom and WebEx made it possible to have even more meetings, because now nobody had to set aside long periods of time for travel and meetings. As a result, meetings were often arranged to deal with one particular issue or with limited agendas. Since I became President in March 2020, I have taken part in 44 meetings. They were equally divided 22 by virtual means and 22 as traditional meetings. While both have their merits, I feel that a face-to face meeting is more effective since it gives opportunities for other incidental topics to be covered and permits networking.

In this new digital environment even the correspondence of our organization has changed. By far the majority of our communication has been by email. In fact, I used Canada Post for only five pieces of mail during the last year, all of which were in connection with this BGM. Traditional telephone calls were limited as well. We did use email over 600 times during that same period. In addition, email is the main mode of communication between our Divisions and members. It is vitally important that the RTANL be made aware of changes to your email address to ensure that you are kept in the loop of all our events.

Since our last BGM, the Executive has met at various locations in the province. We had intended to hold each of our executive meetings in one of our Divisions. This was not possible, but we did meet in Clarenville and Marystown. During these two meetings we had the opportunity to have lunch with the retired teachers in area. These interactions were wonderful opportunities for us to share information and gain insights into what our members view as areas of concern. It is from these meetings that we plan our priorities, having a firsthand knowledge of members concerns is a great place from which to plan.

A vital part of our organization is the Retired Teachers Foundation for Children's Charities (RTF). As we departed our last BGM we did not have a solid plan for our Foundation as no Division had come forward offering to oversee the work of the Foundation for 2020-2022. After the meeting a group of retirees from the Con-Tri Division offered to act as the Foundation Board of Directors. A delegation of the new Board of Directors travelled to Corner Brook to meet with the outgoing Board. After some growing pains the Con-Tri group are up and running. The work of the Foundation has continued uninterrupted and we continue to donate to our worthy charities.

This year saw Memorial University of Newfoundland and Labrador celebrate the 100th Anniversary of the Faculty of Education. They invited the RTANL to be part of the event. We took part in two seminars at the Rooms in May. The first, on the evening of May 4, was a presentation by Dr. Gerald Galway on the **History of Teacher Education in NL.** The second session, on May 5 was a panel discussion, the topic was **Teaching in Pandemic**

Times. In addition, I represented our organization at a panel discussion during the Symposium that was held in September. Throughout the year our members have been involved in the Facebook online series Teacher Tales, hosted by Dr. Jan Bulle. Our members regaled the Facebook audiences with their remembrances of years of teaching and the myriad of situations they encountered. Some stories were downright hilarious while others were almost heartbreaking.

In keeping with the theme of celebrating the Faculty of Education, The RTANL commissioned a triptych piece of artwork by Donald Short and presented it to Memorial University of Newfoundland and Labrador during the 100th anniversary celebration symposium on September 16. This piece of artwork will hang permanently in the lobby of the Hickman building. The triptych pays homage to our journey as teachers in this province and the role of the Faculty of Education in shaping the education of students in this province.

This year at the Memorial University/NLTA Ceremony of Induction into the Teaching Profession which was held on June 2, 2022 at Glendenning Golf, St. John's the RTANL was invited. Don White, our secretary represented us. Our presence at the event was noted, by a welcome from the podium by Stefanie Tuff, NLTA Executive Director. It is nice to have our role in the lives of teachers acknowledged right from the start of their careers. After all they are not only the future of education in this province but they are the future of our organization as well.

As president of the RTANL, I attended both ACER/CART AGM's. Last year's AGM was held as a virtual event in keeping with health protocols. I represent the RTANL as a Director, while our Vice President, Joe Lafitte represented us as an observer. This year both Joe and I, in our respective roles, met with our counterparts in Ottawa during the first week of June. This meeting saw representatives of all the retired teachers' associations across Canada meet to discuss areas of mutual concern. Our collective concerns as retired teachers centre around pension reform, universal Pharma care, and long-term care standards. The Canadian Association of retired teachers actively engages with our counterparts across the country and with our elected representatives in Ottawa to further actions which ensure a more secure future for our retirees. Albert Legge, our past president, sits on the Health Committee with ACER/ CART.

The East Coast Retired Teachers' Organization (ECRTO) meets every second year. This year myself and, a yet to be confirmed, executive member will meet with our fellow retirees in Montreal in late October. ECRTO engages in many of the same political objectives as we do, such as physician availability, vaccination availability and cost of living indicators. The issues experienced by Atlantic Canadian retirees are indeed different than those in other parts of the country.

The Coalition of Seniors, Retirees and Pensioners (Coalition) is our closest ally, we have two members of the executive who sit on the Coalition and between them ensure that we have an attendee at all meetings. The Coalition makes active representation to the various governmental agencies at both the Federal and Provincial level on any and all issues that are of importance to seniors. The Newfoundland and Labrador Public Sector Pensioners Association, of which the Coalition is a component, has expanded and hired an executive assistant, Sharron Callahan. We are bound to benefit from our association with this growing and dynamic organization.

The RTANL needs the support and active participation of all our members if we are to continue to thrive. I am certain that, if the registration for this BGM is an indication of our future, we are in good hands going forward.

(Addendum)

No matter how much you write, or how much you edit as soon as you hit send you automatically remember something you should have added. This is exactly what happened to me right after I submitted my Presidents Report for the BGM package.

Even before I heard the familiar swoosh sound I remembered about the Pre Kindergarten program and how we were invited to be part of the process. I was contacted by Scott Linehand, Assistant Deputy Minister of Education very early in the process and invited to give some input on behalf of the Retired Teachers Association. We were also approached from the start as potential teachers in the program. We were finally being recognized for our experience and expertise in the area of education and especially early education. There have been many times over the last year and half that I have been proud to say that I am President of the RTANL. The role has kept me quite busy.

The position of President has brought with it the opportunity to sit on incidental committees, and to be part of some unplanned meetings. Over the past term of office I have met all of the provincial MP's, Minister of Seniors Filomena Tassi, both our ministers of Education and Health, and both Seniors Advocates. I even had the chance to attend the Manitoba Retired Teachers Association Group Insurance Meeting by Zoom in September. There were numerous online surveys that were submitted ranging from equity and diversity surveys to income and seniors issues.

I have been invited to be a member of the Faculty of Education Selection Committee for the Legacy of Leadership Awards. As a representative of the retired teachers association I am a member of the Arts Subcommittee for the 100th Anniversary of the Faculty of Education Celebration.

The Executive has worked hard on the development of the motions for this BGM. We had to come to terms with what would need to happen if we ever ceased to exist. It was difficult for us to get our minds around this concept. We felt it was better to have a plan in place rather than write a plan as we were in the process of shutting down.

As I reflect on my printed message I realized that I had forgotten to thank the Executive, a knowledgeable and professional group of people who have shared the load of this office. They have gone out of their way to help in any way they could. I could not have a better support team and I appreciate everything you have done, it has not gone unnoticed.

As I embark upon another term I am confident that I will have the continued support of the Executive. I look forward to the next two years with excitement and enthusiasm.

a. BASIS OF ACCOUNTING

The basis of accounting applied in the preparation of the statement of financial position of The Retired Teachers' Association of Newfoundland and Labrador as at July 31, 2022, and the statements of revenues and expenditures, changes in net assets and cash flows for the period then ended is the historical cost basis and reflects cash transactions.

b. PURPOSE OF THE ASSOCIATION

The Retired Teachers' Association of Newfoundland and Labrador (the "association") is an organization of retired teachers in Newfoundland and Labrador. The purpose of the organization is to increase the professional and social contacts of its members, to maintain a liaison with the Newfoundland and Labrador Teachers' Association, to speak for retired teachers on matters that affect them by virtue of the fact that they are retirees in society, to improve the financial status of teachers retired under the Newfoundland and Labrador Teachers' Pension Act, to keep members informed on developments in education and to support public education and encourage members to be concerned about and become involved with social issues.

BGM Motions/Resolutions Proposed Changes to The Constitution and The By-Laws – BGM 2024

Proposed Changes to Constitution and By-Laws

The following are proposed changes to The Constitution and The By-Laws as proposed at the Provincial Executive meeting on May 6/7, 2024. These changes will be voted on at BGM 2024 in October.

New Constitution Article: Article XIV

If in future any Division should, for whatever reason, become defunct (cease to exist):

- (a) The individual members of said Division shall be given the choice of (a) becoming a member of a **nearby Division** OR (b) becoming a member of a Division of **her/his choice**.
- (b) All monies held in an account of said defunct Division shall be deposited to the account of Provincial Executive.

By-Law Change:

BE IT RESOLVED that the current **B-Law Article I: Quorum** be amended:

CURRENT:

That at the Biennial General Meeting and at Special Meetings (either in person or virtually) a majority of the Provincial Executive plus twenty-five (25) Active Members who attend, having been given at least thirty (30) days notice, shall constitute a quorum.

PROPOSED:

A That at the Biennial General Meeting and at Special Meetings (either in person or virtually) a majority of the Provincial Executive plus twenty-five (25) Active Members, having been given at least thirty (30) days notice, shall constitute a quorum.

B. That the deadline for Registration for any BGM shall be the end of August of the BGM year. This will allow for cancellation of the BGM should a Quorum not be met.

C. Following a cancellation of a BGM, a second call for a BGM with at least thirty (30) days notice shall be given by a posting on our website, a mailing to Active Members who have requested a hard copy of the Newsletter AND an email posting to Active Members who have provided an updated email address. A quorum shall then constitute the number of Active Members present at such second meeting.

(Note C is necessary should numbers at the second call fail to reach numbers in A).

Addition to By-Laws:

The **By-Laws Article II E Voting** shall **have number 5** added as follows:

5. Voting at all meetings shall be by registered, Active Members who are in attendance.

RTANL Executive Report to BGM October 2-4, 2024

President -- Sharon Penney

This is my second Presidents Report to BGM. Our Constitution prevents me from continuing in my current role. Presidents can only serve for two consecutive two-year terms. I have learned a lot over the past four years. I have enjoyed sharing the good work of our organization with our members.

Since our last BGM some of us have seen a slight increase in our pensions. The Teachers Pension Plan Corporation indicates that since the cost of living increased drastically the mechanism whereby our pensions increase kicked in. Indexing is provided to Members who retired after August 31, 1998 and who have reached the age of 65 on September 1 of each year. The formula is sixty percent (60%) of the annual change in the national Consumer Price Index as published by Statistics Canada for the prior calendar year, to a maximum annual increase of 1.2%. With Pension Reform, indexation has been suspended for service accrued after August 31, 2015. Even though some did see an increased pension the cost of living has increased over that same time at a much higher level.

On a more positive note, we as retirees are now covered under a new Pharma Care Plan. While this plan currently only covers a limited number of medications and medical supplies it is a great starting point. Through the continued advocacy of the RTANL, ACER-CART and other organizations with whom we maintain a working relationship further advances and improvements will be made to the plan. The National Dental Plan has been enacted, but because our retirees are able to access a dental plan through our Group Insurance they do not qualify for the benefits offered under the dental initiative.

At the provincial level seniors over the age of 75 will no longer have to pay for medical documentation in order to renew their driver's license.

Our Health Plan, while still strong, is experiencing not only a high level of usage, but it is covering very expensive treatments. These two factors are being carefully monitored by the Group Insurance Managers. New, emerging and expensive medications have the potential to negatively impact our Health Plan, containment measures will be discussed going forward. My tenure as a Group Insurance Manager with the NLTA came to an end in July after seven years. I have been replaced on the committee by Craig Hicks, one of our current executive members. His appointment started in August. He will receive training in the fall for his new role.

We, in conjunction with other Retired Teachers Organizations across Canada completed a (SWOT) analysis. This project had us identify the strengths, weaknesses, threats and opportunities that exist within our organizations and how we can use this information to strengthen our own association. I know that the new executive will utilize this information to plan for our own organization as we evolve into a body better designed to meet the needs of retirees in a new age.

During the summer I contacted all the Retired teachers in Labrador between Lance au Clare and Port Hope Simpson for which we had a contact address. I had the pleasure of meeting with Margaret Saulter of Forteau on July 17. We had a lovely visit and lunch at the Northern Lights Restaurant. My conversation with Ms. Saulter revealed that despite our geographical distance many of our concerns show a commonality. The cost of living, lack of services for seniors, and

accessibility of medical personnel and the necessity of a support system, especially for single retirees, were all identified as being of particular concern in Labrador. I had hoped to meet with more retired teachers in Labrador but conflicting schedules made it impossible. I thank Mr. Sean Weir, a NLTA Executive Member, for his assistance and promotion of my visit to Labrador.

At this BGM we will acknowledge the retirement of our long-standing Treasurer, Mr. Clayton Rice. Clayton has made the difficult decision to leave his post after 30 plus years. We held out hope until the bitter end that he would reconsider, but alas he was determined to be finished with a formal position on the RTANL Executive. He has spent more hours than we can calculate diligently doing the work of the Association. He has made that many trips to the NLTA Office over the years that some assume he works there. No one can ever know the number of phone calls he has made to the pensions division on behalf of our members or the number of times he has gone to the Credit Union to complete tasks necessary for the smooth and effective operation of the RTANL . To go from such an active position on the Executive to retirement is going to be taxing in itself, but undoubtedly Clayton has a plan for his time. We all wish him a happy and long retirement.

I will take this opportunity to welcome our new executive. They are demonstrating their belief in the RTANL by offering themselves to work on our collective behalf. I stand ready to aid their transition to the Executive Table. I look forward to my new role as Past President.

The BGM Committee are to be commended for the efforts they have put into making this BGM so successful, it takes a massive effort to put this event together in such a seamless manner. The sheer number of hours put into the organization of this event is staggering. The number of points of contact that were made are endless.

To the Executive that has been my source of support for the last four years, I will be forever in your debt. When you have been called upon to assist me or to replace me at events you were ready to pick up the gauntlet. You have made my job easier while in some cases making your own position more taxing. I thank you for each and every time you put the association ahead of yourselves.

As I relinquish my title of President, I am bouyed in my belief that the RTANL will continue to be an active voice for retired teachers, through our own efforts and through the combined efforts of the different organizations with whom we share a common goal. That being an improvement in the day to day lives of retired teachers across this province.

1. BASIS OF ACCOUNTING

Each year a minimum two formal Foundation committee meetings were held. The satisfaction of knowing that time in retirement can still be used to make a difference in the lives of children is invaluable. Alongside this satisfaction comes the privilege of meeting so many fellow retirees all across this province, not to mention the personal growth of learning so much about the Foundation and the RTANL! I am truly thankful for this opportunity. The time has now come to hand over the administrative responsibilities and sponsorship to another Division. As Chair of the Foundation, I have had the pleasure of attending and presenting at various provincial and local meetings. Notably, it was a delight to participate in the Con-Tri Outing in Lower Island Cove and the Division Presidents Meeting in St. Johns. Additionally I presented at meetings in Clarenville bringing together Con-Tri and one of the newest Divisions, Tri-Bay. Many members were previously unaware of the Foundation's mission and impact so I enjoyed the opportunity to provide an overview during these presentations. Information about the Foundation is now included in the NLTA Pre-Retirement packages and at the seminars. Special thank you to Sharon Penny for including this in your provincial agenda! I feel our membership has become increasingly more aware of the Foundation and the great things that are happening.

In addition to its primary mission, the Retired Teachers Foundation has remained dedicated to its second mandate: managing the Book of Remembrance. This cherished project commemorates the lives of deceased members of the Retired Teachers Association, ensuring that their legacies are preserved for future generations. Families of deceased members provide biographical information and a photo, which can then be carefully recorded and made available for online review. We have made the process of submitting information more accessible and user-friendly. An updated information form is now available online and can be printed and mailed or submitted electronically. This year we received 38 submissions by mail. These were recorded by our Foundation board member Calvin Young. Thank you Calvin for your dedication. All submissions are now available for online viewing. Currently, the Book of Remembrance has six volumes which have been deposited to the Room's Archives and are available for viewing. As new entries are received online, hard copies are being added to a seventh volume which will also be deposited when complete. Thank you NLTA office personnel for your assistance.
